COUNCILMEMBERS' REPORTS, APPOINTMENTS AND FUTURE AGENDA ITEMS

Councilmember Lutes clarified that in 2007 the City Council considered the apartment complex development on Constitution Blvd and was approved by a 5:2 vote. She requested that as new developments are proposed in the area, staff work with the developer to ensure a traffic study is conducted and traffic mediation measures are addressed.

Councilmember Castaneda expressed concerns regarding improving the relationship between the community and the Police Department and requested a plan of action and a community meeting in District 1. He appointed Antonio Castillo to the Traffic and Transportation Commission and Jose Rafael Martinez to the Library and Community Services Commission. He requested a presentation on fracking. Councilmember Castaneda announced there will be a District 1 Clean-up on June 25 at Natividad Creek Park.

Councilmember McShane announced he is hosting an arts and culture summit on June 15, 2016 in the Rotunda at 6 p.m. He announced there are a number of events occurring at the Los Olivos/Riker Neighborhood if anyone is interested in attending. Councilmember McShane added that there is a new mobile application for reporting fireworks. He announced the upcoming Salinas Valley Food and Wine Festival is on August 13, 2016. He announced the Subcommittee on Commissions, Board and Committees will be meeting on Monday, June 20, 2016.

Councilmember Craig reported PAL had a successful Car Show event and they continue to seek ways to raise funds. Councilmember Craig appointed Brad Griffin to the Planning Commission. She expressed concerns regarding the mobile app for reporting illegal use of fireworks and emergency situations associated with fireworks. Councilmember Craig announced she will not be in attendance at the June 28, 2016 meeting as she has her in-residency for her Master's program.

Councilmember Barrera stated he attended a meeting at the Senior Center and added that the Library and Community Services Director will be looking at innovative ways to provide services for both youth and seniors in the same facility. Councilmember Barrera appointed Jack Alisea to the Measure V Oversight Committee.

Councilmember De La Rosa stated she hosted a successful community meeting in District 4. She thanked all the agencies that participated and disseminated information regarding services throughout the City.

Mayor Gunter added that the City is in the process of hiring outreach workers that will be overseen by the Community Safety Division. Mayor Gunter expressed concerns regarding comments posed by Mr. Amit Pandya allegations.
