## A RESOLUTION AUTHORIZING THE EXECUTION OF FY 2025-26 TOW SERVICE FRANCHISE AGREEMENTS, SETTING THE NON-EXCLUSIVE FRANCHISE FEE FOR POLICE TOWING, AND MAINTAINING THE \$1,500 CREDIT FOR DISPOSAL OF RECREATIONAL VEHICLES

**WHEREAS,** the City of Salinas, through its Police Department, manages a rotational tow program to support the Police Department's operations and enforcement of the law; and

**WHEREAS,** tow companies provide service to the Salinas Police Department pursuant to a franchise issued by the City and a Tow Service Franchise Agreement entered into between the City and the tow companies; and

WHEREAS, each tow company is required to pay a franchise fee to the City during the term of the franchise in an amount set by Resolution of the City Council pursuant to Salinas Municipal Code section 20-191; and

**WHEREAS,** the franchise fee is based on the number of tows generated and the City's actual costs in managing the franchise tow program and is paid quarterly by the franchised tow companies; and

WHEREAS, the Salinas Police Department, from time-to-time, orders the tow of an oversized vehicle including, for example, a recreational vehicle. Such vehicles require specialized equipment and services because they contain hazardous materials or substances (including, for example, human waste and refrigeration chemicals) which, if not property disposed of, can negatively affect the health, safety, and welfare of the community. Such vehicles are sometimes inoperable and incapable of being driven or otherwise moved without the assistance of a tow truck, rendering them with little to no value; and

**WHEREAS,** because of the condition of some oversized vehicles, and the need for them to be properly cleaned, transported, and disposed of, the franchise tow companies sometimes realize a loss of revenue as a result of assisting the Salinas Police Department with the tow and the removal of some oversized vehicles.

**NOW, THEREFORE, BE IT RESOLVED** the City Council authorizes the City Manager to execute the FY 2025-26 Tow Service Franchise Agreements with the franchise tow companies; and

**BE IT FURTHER RESOLVED** by the City Council, that to accommodate the Salinas Police Department's need for the tow and removal of oversized recreational vehicles, and the negative financial effect on the franchise tow companies as a result of being called upon to tow and dispose of an oversized recreational vehicle, in some instances the franchise fee due and payable to the City from each franchise tow company may be reduced by up to one thousand five hundred dollars (\$1,500) for each oversized vehicle towed by each company as further specified in the Tow Service Franchise Agreement; and

**BE IT FURTHER RESOLVED** that in the event a franchise tow company's franchise fee is fully reduced to zero as a result of having towed and removed such oversized recreational vehicles, the franchise tow company will not be required to pay a franchise fee but will not receive a credit for additional tows completed beyond the value of the franchise fee.
