#### **EXECUTIVE SUMMARY:**

The budget process is designed to efficiently and effectively receive and incorporate community input, allow staff to prepare and present a proposed budget, and allow the City Council time to review and direct staff on the budget prior to bringing the final budget back for adoption. For this administrative report, the Finance Director will present an overview of the budget process, present summary information on components of the budget, provide in-progress results on the community survey and results of the recent community meeting, and present how the public and City Council can provide input on budget priorities and the budget development.

#### **BACKGROUND:**

The FY 2021-22 budget process began in mid-February. Staff presented the budget process to the Finance Committee on March 1, 2021. Staff released a community survey in mid-March and conducted a virtual community meeting on March 24, 2021. The community survey will be kept open until the end of April 2021. The following list are public opportunities where the community could get involved and communicate their priorities:
