DISCUSSION:

Audited Basic Financial Statements

The Finance Department is pleased to present the audited financial statements for the fiscal year ended June 30, 2018. The transmittal letter in the Basic Financial Statements beginning on page "i" and the Management Discussion and Analysis beginning on page F-5 provide an overview of the City's financial activities for the fiscal year.

McGilloway, Ray, Brown & Kaufman, the City Council's independent auditor, has completed their annual audit of City affairs. Their Independent Auditors Opinion Report is included in the Basic Financial Statements on page F-1 and is a "clean audit" opinion stating, "In our opinion, the financial statements... present fairly, in all material respects, the respective financial position of the governmental activities, the business-type activities, each major fund, and the aggregate remaining fund information of the City, as of June 30, 2018."

Single Audit Report on Federal Funded Programs

The Finance Department is also pleased to present the Single Audit Report of federal funded programs for the fiscal year ended June 30, 2018. The report includes a summary of the federal financial awards, internal control, compliance and schedule of findings and questioned costs for the fiscal year ending June 30, 2018.

McGilloway, Ray, Brown & Kaufman has completed their annual audit of City of Salinas compliance requirements. During the audit, they noted no instance of non-compliance.

CEQA CONSIDERATION:
