Commissioner Davis encouraged the public to use the Salinas Connect App to report potholes and other storm damage.


Commissioner Davis asked to observe a few moments of silence in recognition of fallen officer JD Alvarado, who we lost last February 25th.

Meeting was adjourned at 6:21PM.


