ID#24-071 **Prevention & Wellness Grant Program Update**

Community Safety Administrator, José Arreola, presented the Prevention & Wellness Grant Program Update to the commission. Mr. Arreola reviewed the history of the grant program and its ongoing success. After City Council approved \$300,000 to fund the grant for an additional year, six grantees were awarded up to \$60,000 each for local programs supporting youth, vulnerable adults, and seniors.
