

**SALINAS PLANNING COMMISSION  
RESOLUTION NO. 2018-003**

Resolution Recommending that the City Council approve the Housing Element Annual Progress Report for 2017 and authorize its submittal to the State of California Department of Housing and Community Development and the Governor's Office of Planning and Research

**WHEREAS**, Section 65400 of the California Government Code requires the City to file an annual report addressing the status of the General Plan Housing Element and progress made toward implementing its goals and policies; and

**WHEREAS**, a Housing Element Annual Progress Report for the Year 2017 was prepared and must be submitted to the Department of Housing and Community Development (HCD) and the Governor's office of Planning and Research (OPR) by April 1, 2018; and

**WHEREAS**, the City of Salinas adopted the City of Salinas 2015-2023 Housing Element in 2015; and

**WHEREAS**, the annual report accurately reflects the City's progress in implementing the goals and policies of the General Plan and Housing Element; and

**WHEREAS**, the Planning Commission has confirmed that the report is not a project as defined by CEQA Guidelines Section 15378 and, therefore, no environmental assessment is required; and

**WHEREAS**, on February 21, 2018, the Planning Commission held a public meeting and reviewed the 2017 annual report.

**NOW, THEREFORE, BE IT RESOLVED BY THE SALINAS PLANNING COMMISSION** that the Planning Commission hereby determines that the Annual Housing Element Progress Report for 2017 (Exhibit A) accurately reflects the City's progress in implementing the Housing Element; and

**BE IT FURTHER RESOLVED** by the Salinas Planning Commission that the Commission recommends that the Salinas City Council approve the Housing Element Annual Progress Report for 2017 and direct staff to submit the subject document to the State of California Department of Housing and Community Development and the Governor's Office of Research as required by statute.
