TITLE: AMENDMENT TO MEMORANDUM OF UNDERSTANDING FOR

ASSOCIATION OF MANAGEMENT PERSONNEL OF SALINAS

RECOMMENDED MOTION:

It is recommended that the City Council approve a resolution:

- 1. Amending the Association of Management Personnel of Salinas (AMPS) Memorandum of Understanding (MOU) to extend the current City contribution for health premiums through December 31, 2026; and
- 2. Authorizing an increase in the corresponding health benefit appropriations within the respective funds in an amount up to \$43,000.

EXECUTIVE SUMMARY:

The proposed amendment to the AMPS MOU is to extend the current City contribution for health premiums through December 31, 2026.

BACKGROUND:

The City offers several different health benefit plans to employees, each with different premium amounts. The City currently contributes toward the monthly health benefits premiums an amount equal to 95% of the premium for the plan selected, up to a maximum of 90% of the cost of the premium for the PERS Platinum Health Plan (one of the plans offered by PERS). In November 2023, the City Council approved a resolution approving the AMPS MOU which included a provision for a City's health premium contribution in an amount equal to 95% of the premium for the plan selected and decreased of up to 90% of the California Public Employees' Retirement System (PERS) Platinum plan premium effective January 1, 2025; a contribution of 95% of the premium for the plan selected and a further decrease of up to 85% of the PERS Platinum plan premium, effective January 1, 2026.

Staff recommends maintaining the City's current 2025 premium contribution of 95% of the plan selected, up to 90% of the PERS Platinum plan premium through December 31, 2026 to maintain parity with other employee groups and support recruitment and retention.

FISCAL AND SUSTAINABILITY IMPACT:

The projected cumulative total for the proposed action represents a cost of approximately \$43,000 in the current fiscal year. While some or most of the additional expenditures may be absorbed through salary savings, staff is requesting authority to increase the salary & benefits appropriations in the event that there is no savings within a department.
