SUBJECT: ACCEPTANCE OF REVISION OF RESOLUTION 21015 TO INCLUDE

MANDATORY ADMINISTRATIVE LANGUAGE FROM BOARD OF STATE

AND COMMUNITY CORRECTIONS

#### **RECOMMENDATION:**

It is recommended that the City Council approve the attached resolution, to supersede Resolution 21015, that includes mandatory administrative language required by Board of State and Community Corrections (BSCC).

## **DISCUSSION:**

On July 12, 2016, Salinas City Council approved Resolution No. 21015 authorizing acceptance of grant funding from Board of State and Community Corrections Strengthening Law Enforcement and Community Relations program. Pursuant to the grant requirements, recipient agencies are to provide a resolution prior to releasing of funds. The Salinas Police Department is the Lead Applicant with the Community Safety Division being responsible for grant administration.

On August 10, 2016, Resolution 21015 was sent via email to BSCC. On September 16, 2016 the fully executed contract was received from BSCC. On September 23, 2016, BSCC advised the Community Safety Division that Resolution 21015 did not include mandatory administrative language.

The revisions incorporated into the proposed Resolution do not change any programmatic conditions of the grant or monetary award.

#### **ISSUE:**

Shall the City Council approve the attached resolution, to supersede Resolution 21015, that includes mandatory administrative language required by Board of State and Community Corrections (BSCC)?

# **FISCAL IMPACT:**

There will be no direct fiscal impact to the City's General Fund.

# TIME CONSIDERATIONS:

A resolution should be approved on November 29, 2016, to reduce delay in the City being reimbursed for services. The City will not receive payment for submitted reimbursements until the revised resolution is received.

# **CITY COUNCIL GOALS:**

The attached resolution approving the revision of Resolution No. 21015 eliminates any delay of services and remains consistent with the City Council's goals for a safe, livable community and quality of life.

#### **ALTERNATIVES:**

The City Council may elect not to approve the proposed attached resolution; however, this is not recommended as doing so will compromise the City's ability to receive and to implement the grant.

#### **CONCLUSION:**

The services outlined in Resolution 21015 remain in the revised Resolution which now includes the mandatory administrative language required by BSCC. The efforts in the revision remain consistent with the City Council's goals for a safe, livable community and quality of life.
