As of December 31, 2023 the Measure G expenditures were as follows:

Department - Amount; % Used Administration - \$139,894 (44%) Human Resources - \$82,328 (44%) Finance - \$294,482 (46%) Community Development - \$601,040 (25%) Police - \$3,023,712 (49%) Fire - \$832,094 (45%) Public Works - \$2,454,790 (48%) Recreation - \$2,059,809 (53%)
