RESOLUTION AUTHORIZING BID AWARD AND EXECUTION OF CONTRACT WITH ANDERSON PACIFIC ENGINEERING CONSTRUCTION, INC. FOR THE BASE BID, IN THE AMOUNT OF \$416,923.00 FOR THE EL DORADO PARK BIORETENTION PROJECT, PROJECT NO. 9670 AND TRANSFER \$60,000 FROM THE SOUTH SALINAS DRY WEATHER RUNOFF CIP 9075 TO CIP 9670

WHEREAS, representatives of the City Clerk of Salinas on May 17, 2016, at a public meeting held in the Rotunda Conference Room at Salinas City Hall, at Salinas, California, publicly opened, examined and declared all bids or proposals delivered to or filed with said City Clerk for the El Dorado Park Bioretention Project, Project No. 9670, in accordance with the plans and specifications for such work filed in the office of said City Clerk and now on file in said office; and

WHEREAS, the lowest bidder, Anderson Pacific Engineering Construction, Inc., submitted Base Bid that is 0.74% below the Engineer's Estimate, and an additional \$60,000 is needed to have sufficient funds to award this project; and

WHEREAS, City staff there upon reported the results of the bidding to the City Council at its regular meeting on July 12, 2016, and the Council in open session at said meeting examined the report of staff.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL that pursuant to Salinas City Charter Section 81 and City Code Section 12-21, in reference to the El Dorado Park Bioretention Project, Project No. 9670, that all of said bids or proposals are rejected except the bid of Anderson Pacific Engineering Construction, Inc. (hereinafter referred to as "The Successful Bidder"), being the lowest and best bid which is hereby accepted (Base Bid). The subject contract the Base Bid is hereby awarded to said Successful Bidder for the sum of \$416,923.00, and more specifically at the unit prices particularly set forth and contained in the Proposal for the El Dorado Park Bioretention Project, Project No. 9670, of said Successful Bidder previously filed in the office of the City Clerk. Said sum shall be paid by the City of Salinas to said Successful Bidder in cash, lawful money of the United States of America, payable at the time and in the manner specified in the plans and specifications and contract documents for

the project filed in the office of the City Clerk, entitled "El Dorado Park Bioretention Project, Project No. 9670".

BE IT FURTHER RESOLVED that said plans and specifications are hereby referred to

for all of the details and particulars thereof, and said plans and specifications are by reference

incorporated in and hereby made a part of this resolution;

BE IT FURTHER RESOLVED that Council approve the transfer of \$60,000 from the

South Salinas Dry Weather Storm Runoff CIP 9075 to CIP 9670;

BE IT FURTHER RESOLVED that the Mayor of Salinas is hereby authorized and

directed on behalf of the City of Salinas to execute a contract consistent with the Proposal of said

Successful Bidder for said work.
