This letter is written to submit the Airport Layout Plan (ALP) Update (Informal Revision) for Salinas Municipal Airport (SNS) for FAA approval. C&S Engineers, Inc., has been working with the City of Salinas (City), the owner and operator of Salinas Municipal Airport, in the preparation of informal revisions to the ALP Update. The following denotes the changes that were made from the previously FAA approved ALP from 2017:

Edits/Revisions:

 - a. Runway 31 markings revised to precision markings.
 - b. Threshold Siting Surface categories and dimensions revised to reflect the changes in FAA EB. #99.

 - d. Airport Owned NAVAIDS revised to reflect REILs on Runway 13 and 26 ends for both existing and future conditions.

4. Inner Portion of the Approach Surface – Runway 13
 - a. TSS dimensions/label revised in plan view and label in profile view.
5. Inner Portion of the Approach Surface – Runway 31
 - a. TSS dimensions/label revised in plan view and label in profile view.
6. Inner Portion of the Approach Surface – Runway 26
 - a. Ultimate TSS dimensions/label revised in plan view and label in profile view.
7. On-Airport Land Use Drawing
 - a. Increased size of the Non-Aeronautical Revenue Support Area in the SW quadrant of the property.
