**A RESOLUTION APPROVING MASTER SERVICES AGREEMENTS FOR UNARMED SECURITY GUARD SERVICES BETWEEN THE CITY OF SALINAS AND URETSKY SECURITY, SECURITAS SECURITY SERVICES, AND FIRST ALARM SECURITY**

**WHEREAS**, the City of Salinas recognizes the benefits provided to the general public and cost savings by contracting unarmed security guard services for its libraries, parks, the Airport, Train Station, parking facilities, and other City-owned facilities; and

**WHEREAS**, historically, the City has contracted for security services in a decentralized as-needed basis as required by each City Department, resulting in irregular pricing and programs; and

**WHEREAS**, on July 5, 2017, a Request For Proposals (“RFP”), was published on the City’s Planet Bids website, City web site, and in the local newspaper seeking qualified vendors to provide unarmed security services for City facilities; and

**WHEREAS**, by August 4, 2017, at the close of the proposal submittal deadline, the City received nine proposals from qualified vendors to provide unarmed security guard services for various Departments and City facilities; and

**WHEREAS**, a competitive process assigning points to various criteria used by the RFP Evaluation Team representing a cross section of City Departments to rank the proposals and the firms’ qualifications; and

**WHEREAS**, the Evaluation Team recommends that the three top firms be considered for the opportunity to provide unarmed security services for Salinas. The actual contracts will be contingent on each City Department’s needs catered to each individual scope of work within their respective budget limitations.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SALINAS**, that the City Council hereby finds and determines that the above recitals and accompanying staff report are true and correct and have served as the basis, in part, for the actions of the City Council set forth below; and

**BE IT FURTHER RESOLVED**, that the Master Services Agreements between the City of Salinas and Uretsky Security, Securitas Security Services, and First Alarm Security, to provide unarmed security guard services for the City of Salinas are hereby approved; and

**BE IT FURTHER RESOLVED**, that the City Manager or his designee, is hereby authorized and directed, for and on behalf of the City of Salinas, and as its act and deed, to execute the attached Master Services Agreements; and

**BE IT FURTHER RESOLVED**, that the City Manager is authorized to execute extensions and/or modifications to the Agreements and to take whatever additional action may be necessary to effectuate the intent of this resolution.
