

**AGREEMENT —AMENDMENT NO. 4 TO
UNIFORM LAUNDRY AND RENTAL SERVICE
BETWEEN
CINTAS INCORPORATED AND CITY OF SALINAS**

This Amendment No. 4 to the Uniform Laundry and Rental Service (the “Amendment”) is entered into this 13 day of July 2023, by and between the City of Salinas (the “City”) and Cintas Incorporated, (the “Contractor). City and Contractor may be individually referred to herein as a “Party” and collectively the City and Contractor may be referred to as the “Parties.”

RECITALS

WHEREAS, the City and Contractor first entered into a/an Agreement for Uniform Laundry and Rental Services effective August 8, 2020, pursuant to which Contractor agreed to act as and provide certain services to the City for compensation (the “Agreement”); and

WHEREAS, the City and Contractor desire to amend the Agreement term to extend services for one year and to reflect the revised compensation to be paid to contractor per approved Resolution 22667.

NOW, THEREFORE, in mutual consideration of the terms and conditions set forth below, the Parties agree as follows:

TERMS

1. The Agreement, TERM and PAYMENT sections, are amended to replace the following:

TERM: The work under this Agreement shall commence August 8, 2020, and shall be completed by August 8, 2023, unless City grants a written extension of time as set forth in Section 2 above.

With:

TERM: The work under this Agreement shall commence August 8, 2020, and shall be completed **August 8, 2024**, unless City grants a written extension of time as set forth in Section 2 above.

And per Resolution 22667

PAYMENT: City agrees to pay, and Contractor agrees to accept as full and fair consideration for the performance of this Agreement, not to exceed \$53,402 per year.

With:

PAYMENT: City agrees to pay, and Contractor agrees to accept as full and fair consideration for the performance of this Agreement, not to exceed **\$75,152** per year.

2. All other covenants, terms, and conditions set forth in the Agreement and not amended by this Amendment shall remain in full force and effect as if fully set forth herein.

IN WITNESS WHEREOF, the undersigned, as authorized representatives of the City and Contractor have entered into this Agreement as of the date first written above.
