**SUBJECT:** Strengthening Law Enforcement and Community Relations Grant, Executive Steering Committee's Funding Recommendations: **Requesting Approval.**

---

### Summary

This agenda item requests approval of the Strengthening Law Enforcement and Community Relations Grant (Strengthening Grant) awards as recommended by the Strengthening Grant Executive Steering Committee (ESC). Recommendations are

- Fully award 9 grants totaling \$5,257,939 for programs and initiatives intended to strengthen the relationship between law enforcement and the communities they serve.
- Offer 1 partial award in the amount of \$442,061 to the Contra Costa County Sheriff's Office, which fell at the funding cut-off point in the ranked list.
- Authorize staff to offer full or partial funding to the next-ranked applicant(s) should an applicant recommended for funding be unable or unwilling to accept the award in order to expend the total balance.

If the proposed list of grantees is approved, the two-year grant period will begin July 1, 2016 and end June 30, 2018.

### Background

The Budget Act of 2015 allocated \$6 million to the BSCC to administer a new grant program. The Budget Act provides:

The Board of State and Community Corrections shall provide grants to local law enforcement for programs and initiatives intended to strengthen the relationship between law enforcement and the communities they serve, including, but not limited to, providing training for front-line peace officers on issues such as implicit bias; funding for research to examine how local policing services currently are being delivered; assessing the state of law enforcement-community relations; comparing the status quo with the best practices in the policing profession; and receiving recommendations for moving forward, including the identification of policing models and operational options to improve policing; problem-oriented policing initiatives such as Operation Ceasefire; restorative justice programs that address the needs of victims, offenders, and the community; behavioral health training and any one-time costs associated with implementing, expanding, and maintaining a program designed to capture peace officer interactions with individuals in the community. The Board of State and Community Corrections may use up to 5 percent of the total amount available in this item to administer this program.

The Budget act further required that to be eligible, the applying agency shall be in full compliance with Section 11108 of the California Penal Code, which pertains to local law enforcement reporting requirements for firearms and property (Attachment D-1).

The BSCC retained 5 percent of the allocation to administer the program. The remaining \$5,700,000 was made available to public agencies through this competitive process.

On September 17, 2015 the Board appointed a Chair and authorized the Chair and staff to form an ESC to oversee the development and release of the Strengthening Grant Request for Proposals (RFP). On this date, the Board also appointed Board Member David Bejarano, Chief of Police, Chula Vista, as Chair of the ESC and delegated authority to the ESC Chair and staff to name additional members to the ESC. The ESC was to include representation from government entities, community based service providers and the formerly incarcerated community, among others. Chief Bejarano subsequently appointed as Co-Chair B.J. Davis of Strategies for Change, a community-based service provider.

- The 15-member ESC (Attachment D-2) convened November 9 and 10, 2015 and again on December 17, 2015 to develop the RFP.
- The RFP was released on February 5, 2016 with a due date of April 1, 2016 (Attachment D-3). The due date was subsequently extended to April 15, 2016.
- 46 proposals were received requesting a total of \$24.4 million.
- On April 28, 2016 the ESC was trained by staff on how to rate proposals.
- On June 2, 2016 the ESC met to discuss scores and develop a ranked list of proposals.

### **Recommendation/Action Needed**

On behalf of the Strengthening Grant Executive Steering Committee, staff recommends approval of the proposed grant awards in ranked order as provided on the following four pages.

The ESC funding recommendations are:

- Fully award 9 grants totaling \$5,257,939 for programs and initiatives intended to strengthen the relationship between law enforcement and the communities they serve.
- Offer 1 partial award in the amount of \$442,061 to the Contra Costa County Sheriff's Office, which fell at the funding cut-off point in the ranked list.
- Authorize staff to offer full or partial funding to the next-ranked applicant(s) should an applicant recommended for funding be unable or unwilling to accept the award in order to expend the total balance.
