WHEREAS, the City Council has carefully examined and reviewed the Report as presented and is satisfied with each and all of the items and documents as set forth therein (or as amended) and found that it contained all the provisions required by the Act, California Constitution Articles XIIIC and XIIID, including (1) plans and specifications of the existing improvements and proposed new improvements; (2) estimate of costs; (3) diagram of the District; and (4) an assessment according to benefits, and that the levy has been spread in accordance with the benefits received from the improvements, operation, maintenance, and services to be performed as set forth in said Report; and

**WHEREAS**, at this time a public hearing has been held relating to the levy of the annual assessment, and the City Council is now satisfied with the assessment diagrams and all other matters as contained in the Report dated, dated July 1, 2025 (Attachment A) as now submitted for final consideration and confirmation.

**NOW, THEREFORE, BE IT RESOLVED,** that the Salinas City Council finds as follows:

- 1. That a transfer of \$130,617 from general funds to the District's Operating Reserve Fund (2109.50) is hereby approved to cover the parks and open space maintenance costs associated with the special benefits received by parcels outside the LMAD's boundaries
  - 2. That the above recitals are all true and correct.
  - 3. That the Report as presented (or amended), including the final assessment and diagram for the proceedings, is hereby approved, and confirmed.
    - a. the land within the District will receive special benefit by the operation, maintenance, and servicing of improvements located in public places within the boundaries of the District; and,
    - b. the District includes all of the lands so benefited; and,
    - c. the net amount to be assessed upon the lands within the District in accordance with the fee for the Fiscal Year commencing July 1, 2025 and ending June 30, 2026 is apportioned by a formula and method which fairly distributes the net amount among all eligible parcels in proportion to the estimated benefits to be received by each parcel from the improvements and services.

- 4. That the Report is ordered to be filed in the Office of the City Engineer as a permanent record and to remain open for public inspection.
- 5. That the assessments as above authorized and levied for these proceedings will provide revenue and relate to the fiscal year commencing July 1, 2025, and ending June 30, 2026.
- 6. That the public interest and convenience requires, and the City Council does order the maintenance work to be made and performed as set forth in the Report (Attachment A) for the next fiscal year are confirmed and levied upon the respective lots or parcels of land in the Assessment District in the amounts as set forth in the Report (Attachment A). It is further determined that all assessments have been apportioned properly in accordance with the benefits that each parcel receives from the proposed maintenance works of improvement.
- 7. That the authorized maximum assessment rates for the District include an annual adjustment by an amount equal to the annual change in the Consumer Price Index, not to exceed 3% per year, plus any uncaptured excesses, and therefore, the assessments are not being increased above their authorized maximum amounts.
- 8. The Finance Department is hereby authorized and directed to file the levy with the County Auditor upon adoption of this Resolution pursuant to *Chapter 4*, *Article 1*, *Section 22641* of the Act.
- 9. The County Auditor of the County of Monterey shall enter on the County Assessment Roll opposite each eligible parcel of land the amount of levy so apportioned by the formula and method outlined in the Report, and such levies shall be collected at the same time and in the same manner as the County taxes are collected pursuant to *Chapter 4*, *Article 2*, *Section 22646* of the Act. After collection by the County, the net amount of the levy shall be paid to the City Treasurer.
- 10. The City Treasurer shall deposit all money representing assessments collected by the County for the District to the credit of a fund known as the Improvement Fund, City of Salinas, Monte Bella Maintenance District such monies shall be expended only for the maintenance, operation, and servicing of the landscaping, lighting, and appurtenant facilities as described in 5 above.
- 11. The adoption of this Resolution constitutes the District levy for the Fiscal Year commencing July 1, 2025 and ending June 30, 2026.
- 12. That the City Clerk shall certify to the passage and adoption of this Resolution, and the minutes of this meeting shall so reflect the presentation of, and final approval of the Report as submitted or amended.
