TITLE: NOVEMBER 3, 2020 MUNICIPAL ELECTION CANVASS

RECOMMENDED MOTION:

A motion to approve a Resolution declaring the results of the November 3, 2020 Municipal Election for the office of Salinas Mayor and City Councilmembers for District 1, District 4, and District 6.

RECOMMENDATION:

Staff recommends Council approve the attached Resolution affirming the Monterey County Registrar of Voters *Statement of Votes Cast* thereby declaring the results of the City of Salinas November 3, 2020 Municipal election.

EXECUTIVE SUMMARY:

On May 12, 2020, pursuant to California Elections code 10002 and Salinas City Charter Article 3, the City Council approved consolidation of the November 3, 2020 General Municipal Election. The election was conducted by the County of Monterey Registrar of Voters and election canvass has been completed. Following the completion of the canvass, Elections Code Section 10263(b) requires the City Council to declare the results no later than December 1, 2020, which is the next regularly scheduled City Council meeting following receipt of the Registrars *Statement of Votes Cast* by the City Clerk's Office.

BACKGROUND:

The Registrar of Voter's has certified the attached results of the November 3, 2020 General Municipal election. The following candidates received the highest number of votes and are thereby elected into office. Elected candidates are scheduled to be sworn into office by the Salinas City Clerk following Council approval and ceremonial oath shall be conducted on December 8, 2020.
