## A RESOLUTION APPROVING SOFTWARE AND SERVICES AGREEMENT BETWEEN THE CITY OF SALINAS AND TRITECH CORPORATION FOR POLICE RECORDS MANAGEMENT SYSTEM SOFTWARE AND IMPLEMENTATION SERVICES, AND PURCHASE OF RELATED HARDWARE

WHEREAS, one of the City Council's priority initiatives and objective in the Safe, Livable Community goal is "Update Technology in Public Safety"; and

WHEREAS, the City Council desires the City to optimize the use of technology to increase efficiency, effectiveness and service to the community; and

WHEREAS, the current police records management system is over 30 years old and outdated and staff desires to consolidate systems for more efficient use and analysis of public safety data to provide additional accountability is services; and

WHEREAS, a functional requirements matrix was developed for the basis of a Request for Proposals (RFP) that was issued by the City on August 20, 2015 for a police records management and field reporting system; and

WHEREAS, the RFP deadline was October 9, 2015 and the City received six responses; and

WHEREAS, the two finalists presented proof-of-capabilities demonstrations to a police review team, reference checks were conducted, and members of the selection team met with the executive staff of both finalists; and

WHEREAS, the selection committee that represented a cross section of users within the police department considered all of the input and due diligence and a unanimous decision was made to select TriTech as the selected vendor, and

WHEREAS, the police department has negotiated an agreement package, including a statement of work, that meets the requirements listed in the functional requirement matrix, and

WHEREAS, required additional hardware, mobile devices, certain require third party software, and interfaces, outside the scope of the purchase agreement with TriTech, will be needed to insure the system meets the functional needs of the Police Department, and

WHEREAS, such required hardware and software will be purchased using cooperative purchasing pricing where possible, and

WHEREAS, pursuant to City Code Section 12-27, the City Council can approve purchases without notice, advertisement or competitive bidding and pursuant to City Code Section 12-28.070 purchases made through cooperative purchasing agreement are exempt for local preference.

WHEREAS, the core networked hardware will be purchased through governmental cooperative purchasing agreements with CDW-G and KIS Virtualization Services with an estimated cost of \$202,000, and

NOW, THEREFORE, be it resolved by the City Council, herby approves the form of the attached services agreement between the City of Salinas, a municipal corporation, and TriTech Corporation, for a police records management system.

BE IT FURTHER RESOLVED, that the City Council, herby authorizes the purchase of required hardware, mobile devices, certain required third party software, and interfaces to insure the system meets the functional needs of the Police Department.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed for and on behalf of the City of Salinas to execute the attached contract with TriTech, in the form presented at this meeting with such changes insertions and omissions, and change orders as may be approved by the City Manager and City Attorney, said execution being conclusive evidence of such approval.
