**A RESOLUTION OF THE SALINAS CITY COUNCIL
APPROVING UNITED STATES DEPARTMENT OF HOUSING AND URBAN
DEVELOPMENT (HUD) FY 2020-2024 CONSOLIDATED PLAN, FY 2020-2021 ANNUAL
ACTION PLAN AND ALISAL NEIGHBORHOOD REVITALIZATION STRATEGY AREA
AND AUTHORIZING SUBMITTAL TO HUD**

WHEREAS, the City of Salinas (City) receives and administers United States Department of Housing and Urban Development (HUD) entitlement Community Development Block Grant (CDBG), HOME Investment Partnerships Program (HOME) and Emergency Solutions Grants (ESG) program funding; and

WHEREAS, the City is required to submit a Fiscal Year (FY) 2020-2024 Consolidated Plan (Con Plan) and FY 2020-2021 Annual Action Plan (AAP) to HUD for approval in order to remain eligible to receive CDBG, HOME and ESG funding; and

WHEREAS, the City is simultaneously updating its Alisal Neighborhood Revitalization Strategy Area (ANRSA) and will submit to HUD concurrently with the FY 2020-2024 Con Plan and FY 2020-2021 AAP; and

WHEREAS, the FY 2020-2024 Con Plan covers the period of July 1, 2020 to June 30, 2025 and identifies the housing and community development needs in the City and sets forth a five-year strategic plan for addressing the identified needs within the context of HUD entitlement CDBG, HOME and ESG funding; and

WHEREAS, the FY 2020-2024 Con Plan serves as the official application to HUD for CDBG, HOME and ESG and includes the first year FY 2020-2021 AAP which covers the period of July 1, 2020 to June 30, 2021; and

WHEREAS, the FY 2020-2021 AAP describes proposed activities, projects, programs and funding amounts to be implemented with HUD CDBG, HOME and ESG; and

WHEREAS, a Neighborhood Revitalization Strategy Area (NRSA) is a special tool allowed under HUD regulations designed to deliver focused revitalization activities to a strategic geographic area such as the City's ANRSA; and

WHEREAS, per the City's HUD Citizen Participation Plan (CPP), the draft FY 2020-2024 Con Plan, FY 2020-2021 AAP and ANRSA were made available to the public for review and comment for a minimum thirty (30) day period from June 27, 2020 to August 4, 2020; and

WHEREAS, the City Council held a duly noticed public hearing on August 4, 2020 to obtain further comments on the draft FY 2020-2024 Con Plan, FY 2020-2021 AAP and ANRSA.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City that it hereby approves the FY 2020-2024 Con Plan, FY 2020-2021 AAP, ANRSA and authorizes the submittal to HUD and that the Mayor Pro Tem or her designee is hereby authorized and directed, for and on behalf of the City to execute any related HUD agreements, contracts, certifications and related documents

implementing the funding allocations set forth in the AAP at such time as HUD submits said agreements to the City.
