SUBJECT: GRIEVANCE BOARD

RECOMMENDATION:

It is recommended that the City Council adopt the attached Resolution authorizing the Grievance Board term extension of Mr. Dean Carothers, and further, appointing Mr. Al Espindola and Mr. Richard Fors to the Grievance Board.

DISCUSSION:

The City of Salinas Grievance Board is a voluntary resident body comprised of four members to hear employee grievances pursuant to the Personnel Resolution and Section 25-43 of the Salinas City Code. The composition of the City's Grievance Board consists of four members appointed by the City Council.

The Human Resources Division solicits nominations on an ongoing basis from both the community and through employee groups, and recently received applications from Mr. Al Espindola and Mr. Richard Fors.

With this Council action of extending one member and appointing two new members, the Grievance Board will be at full strength and will be able to hear any upcoming employee grievances.

ISSUE:

Shall the City Council adopt the attached Resolution authorizing the Grievance Board term extension of Mr. Dean Carothers, and further, appointing Mr. Al Espindola and Mr. Richard Fors to the Grievance Board?

FISCAL IMPACT:

None

ALTERNATIVES:

The City Council may decide not to approve the term extension and appointments, however, this may delay future grievance hearings until the Board is at full strength.

CONCLUSIONS:

The City's Grievance Board currently has three vacancies. Staff recommends that the term for Mr. Carothers be extended, and the appointments of Mr. Espindola and Mr. Fors be made by the City Council.
