TITLE: ARCTIC WOLF MDR SOFTWARE RENEWAL

RECOMMENDED MOTION:

A motion to approve a Resolution delegating authority to the City Manager and Purchasing Agent to renew an annual license for Arctic Wolf MDR from Savant Solutions, Inc. in an amount not to exceed \$109,782.27 for the period August 27, 2025, through August 26, 2026, subject to the appropriation of funds.

EXECUTIVE SUMMARY:

Arctic Wolf, a Managed Detection and Response (MDR) solution, provides the City of Salinas (City) with a security platform that includes a real-time operations center, network security monitoring, and end-user security training platform. The City relies on the Arctic Wolf MDR platform as part of its information security strategy to improve its security posture to ensure the confidentiality, integrity, and availability of its network resources and technology systems.

BACKGROUND:

The City has been using Arctic Wolf MDR since FY 2021-22. This renewal is year three (3) of a three (3) year agreement with Artic Wolf Networks Inc. The end-user security awareness training component was added in 2023 to provide interactive and informative cybersecurity training for City employees. Arctic Wolf MDR provides 24/7 monitoring, detection, and response for the City's network environment that includes servers and end-point devices. Service support items include:

- Centralized security logging and monitoring. Should any concerning security threats arise, City of Salinas Information Technology is promptly alerted.
- Continuous vulnerability and risk management. Included are monthly vulnerability scans that include all public facing components of the network.
- Continuous improvement of security posture, including employee security awareness trainings.

Maintaining the Artic Wolf MDR security software is necessary to support the maintenance and operations of multiple staff activities while protecting the network environment from security threats.
