WHEREAS, City staff thereupon reported the results of the Request for Proposals to the City Council at its regular meeting on September 21, 2021, and the Council in open session at said meeting examined the report of staff;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SALINAS that the Proposals from Granite Construction Company, and Graniterock (hereinafter referred to as "The Suppliers"), are hereby accepted.

BE IT FURTHER RESOLVED that the Proposals from The Suppliers are hereby referred to for all of the details and particulars thereof, and said Proposals from The Suppliers are by reference incorporated in and hereby made a part of this resolution.

BE IT FURTHER RESOLVED that the Public Works Director or Designee is hereby authorized and directed on behalf of the City of Salinas to execute the needed purchase orders related to the purchase of roadway pavement materials for use by the City Street Maintenance Division on an as needed basis for a combined amount not to exceed \$1,500,000 annually for fiscal years 2021-22, and 2022-23 with an opportunity for an extension for two additional years contingent upon mutual agreement between the City and The Supplier.
