2025 AB 481 Annual Report and Renewal of Ordinance No. 2657

Received report from Commander Danny Warner regarding Assembly Bill 481 (AB 481 or the Bill), codified in Government Code sections 7070 through 7075 which required law enforcement agencies to obtain approval from the applicable governing body, by adopting a military equipment use policy by ordinance, prior to taking certain actions related to the funding, acquisition, or use of "military equipment". City Council adopted a military equipment use policy by Ordinance on August 23, 2022, requiring annual renewal. As required by AB 481, the Salinas Police Department (SPD) requested the renewal of Ordinance No. 2657 to allow SPD to continue utilizing this necessary equipment.
