Recommendation

3. authorizing the Mayor, or designee, for and on behalf of the City, to execute any related agreements, contracts, certifications, and amendments related to the funding allocations set forth in the FY 2026-2027 AAP; and
4. authorizing the appropriation of HUD funds to projects and activities described in the FY 2026-2027 AAP.
