TITLE: DIRECT PURCHASE AND INSTALLATION OF FF300 FOUR-FOLD FIRE STATION DOORS

RECOMMENDED MOTION:

It is recommended that City Council approve a Resolution approving the direct purchase of four (4) FF300 four-folding glazed doors, power operated and interior mounted manufactured by Door Engineering and installed by Byron Epp Inc. for \$404,900.00.

RECOMMENDATION

Staff makes this recommendation after research and installation of these doors at Fire Station 5. These doors have a 10-year warranty and are virtually maintenance free with the exception of greasing after 10,000 openings, which Fire Department personnel can do. These doors are the current trend and best practice for station retrofits and new construction of fire stations nationwide.

EXECUTIVE SUMMARY:

BACKGROUND:

The current roll-up doors have exceeded their life span. They were not designed for high usage or rapid opening and closing as required by emergency responders. Currently the doors at Station 1 need servicing and repair frequently. Last fiscal year the City paid out \$217,450.67 for all overhead door repair, with Station 1 needing the majority of repair. In approximately two years, these doors would pay for themselves with the cost saving of expensive repairs. Replacing the current doors with the FF300 four-folding glazed doors would be a fiscally responsible choice. They are designed for high use, quick opening and closing operations that is a necessity for the fire service.

The proposed purchase would be made directly with Byron Epp, Inc. pursuant to the City Council's authority under Salinas Municipal Code Sections 12-27 (Exceptions) and 12-28.080 (Authority of Council to Purchase).

CEQA CONSIDERATION:

Not a project. The City of Salinas has determined that the proposed action is not a project as defined by the California Environmental Quality Act (CEQA) (CEQA Guidelines Section 15378).
