TITLE: FISCAL YEAR 2024 COMMUNITY BUDGET SURVEY

RECOMMENDED MOTION:

No action is required. This report is for informational purposes only.

EXECUTIVE SUMMARY:

The budget process is designed to efficiently and effectively receive and incorporate community input, allow staff to prepare and present a proposed budget, and allow the City Council time to review and direct staff on the budget prior to adoption. For this administrative report, the Director of Finance will provide an overview of the results of the community budget survey, budget priority "pop-ups," community budget meetings, and information regarding additional opportunities for the public may provide input on budget priorities and be engaged in the budget process.

BACKGROUND:

Although, internally, development of the Fiscal Year 2023 budget began in February, City staff released a community budget survey in December 2022 and conducted forty "pop-ups" at various locations throughout the city, which, combined, obtained more than 4,300 responses from the public. In addition, staff conducted four community budget meetings in January and February 2023, with overall attendance totaling over 180.
