A RESOLUTION AUTHORIZING BID AWARD AND EXECUTION OF CONTRACT TO KOBO UTILITY CONSTRUCTION CORPORATION FOR THE SALINAS MUNICIPAL AIRPORT ELECTRICAL UPGRADES; AIP NO. 3-06-0206-25 (CIP NO. 9225) IN THE AMOUNT OF \$723,760.00 (BASE BID PLUS ALL FOUR ADDITIVE ALTERNATIVES)

WHEREAS, on March 22, 2016, the City Council pursuant to Resolution No. 20930 (N.C.S.) approved plans and specifications for the Salinas Municipal Airport Electrical Upgrades; AIP No. 3-06-0206-25 (CIP NO. 9225); and

WHEREAS, representatives of the City Clerk of Salinas on April 20, 2016, at a public meeting held in the Rotunda at Salinas City Hall, at Salinas, California, publicly opened, examined and declared all bids or proposals delivered to or filed with said City Clerk for the Salinas Municipal Airport Electrical Upgrades; AIP No. 3-06-0206-25 (CIP NO. 9225), in accordance with the plans and specifications for such work filed in the office of said City Clerk on March 22, 2016, and now on file in said office; and

WHEREAS, the lowest bidder, Kobo Utility Construction Corporation, submitted a total bid that is 8.53% above the engineer's estimate, and sufficient funds are available to award the project; and

WHEREAS, City staff thereupon reported the results of the bidding to the City Council at its regular meeting on August 16, 2016, and the Council in open session at said meeting examined the report of staff;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL that pursuant to Salinas City Charter Section 81 and City Code Section 12-21, in reference to the Salinas Municipal Airport Electrical Upgrades; AIP No. 3-06-0206-25 (CIP NO. 9225), that all of said bids or proposals are rejected except the bid of Kobo Utility Construction Corporation (hereinafter referred to as "The Successful Bidder"), being the lowest and best bid which is hereby accepted. The subject contract is hereby awarded to said Successful Bidder for the sum \$723,760.00 (base bid plus all four additive alternatives), and more specifically at the unit prices particularly set forth and contained in the Proposal for the Salinas Municipal Airport Electrical Upgrades; AIP No. 3-06-0206-25 (CIP NO. 9225), of said Successful bidder previously filed in the office of the City Clerk, on April 20, 2016. Said sum shall be paid by the City of Salinas to said Successful Bidder in cash, lawful money of the United States of Page 1 of 2 America, payable at the time and in the manner specified in the plans and specifications and contract documents for the project filed in the office of the City Clerk on March 22, 2016, entitled "Salinas Municipal Airport Electrical Upgrades; AIP No. 3-06-0206-25 (CIP NO. 9225)".

BE IT FURTHER RESOLVED that said plans and specifications are hereby referred to for all of the details and particulars thereof, and said plans and specifications are by reference incorporated in and hereby made a part of this resolution.

BE IT FURTHER RESOLVED that the Mayor of Salinas is hereby authorized and directed on behalf of the City of Salinas to execute a contract consistent with the Proposal of said Successful Bidder for said work.
