### AUTHORIZING RESOLUTION

#### City of Salinas

All of the Council members of City of Salinas, municipality, State ESG Administrative Entity hereby consent to, adopt and ratify the following resolutions:

- A. WHEREAS the State of California (the “State”), Department of Housing and Community Development (“Department”) issue a Notice of Funding Availability (NOFA) dated **May 16, 2016**, under the Emergency Solutions Grant (ESG) Program (“Program”); and
- B. WHEREAS City of Salinas is an approved ESG Administrative Entity; and
- C. WHEREAS the Department may approve funding allocations for the ESG Program, subject to the terms and conditions of the NOFA, Program guidelines and requirements, and the Standard Agreement and other contracts between Department and ESG grant recipients;

NOW THEREFORE BE IT RESOLVED THAT: BY THE COUCIL OF SALINAS:

- 1. If City of Salinas receives a grant of funds from Department, it represents and certifies that it will use all such funds in a manner consistent and in compliance with all applicable state, federal, and other statutes, rules, regulations, guidelines and laws (“rules and laws”), including without limitation all rules and laws regarding the ESG Program, as well as any and all contracts City of Salinas may have with Department.
- 2. City of Salinas is hereby authorized and directed to receive an ESG grant, in the amount not to exceed \$600,878 in accordance with all rules and laws.
- 3. City of Salinas hereby agrees to use the ESG funds for eligible activities as approved by the Department and in accordance with all Program requirements, and other rules and laws, as well as in a manner consistent and in compliance with the Standard Agreement and other contracts between State ESG Administrative Entity and Department.
- 4. The Mayor or City Manager or Community Development Director are authorized to execute the Standard Agreement and any subsequent amendments or modifications thereto, as well as any other documents which are related to the Program or the ESG grant awarded to State ESG Administrative Entity, as the Department may deem appropriate.
