SUBJECT: CITY-CALTRANS MASTER AGREEMENT FOR FEDERAL FUNDED

TRANSPORTATION PROJECTS

RECOMMENDATION:

It is recommended that the City Council approve a Resolution authorizing the Mayor or City Manager to execute Master Funding Agreement with Caltrans for administering transportation projects funded with federal money.

DISCUSSION:

A significant amount of City of Salinas Transportation Projects are funded through programs administered by the State of California Department of Transportation (Caltrans). These funding programs through Caltrans use federal funds. To be eligible to use these funding sources, jurisdictions, such as the City of Salinas, are required to execute a Master Agreement with Caltrans.

Agreement No. 05-5045F15— Master Agreement is attached and must be executed for the use of federal funds by the City of Salinas.

Staff recommends the Council authorize the Mayor or the City Manager to execute this master agreement, so the City remains eligible for federal funding. The City's West Alisal Street Safety Improvements Project, is funded by federal funds which will require the execution of this agreement. Thus, the City can seek reimbursement for costs.

ISSUE:

Shall Council approve a resolution authorizing the Mayor or the City Manager to execute the attached Master Agreement for federal funding?

FISCAL IMPACT:

This Master Agreement will allow the City to seek reimbursement for eligible work performed on transportation projects funded by Caltrans programs. There is no impact to the General Fund from the execution of the Master Agreement. These funds are typically the results of successfully secured grants for which the has applied.

TIME CONSIDERATIONS:

West Alisal Street Safety Improvements Project is anticipated to commence design by January 2016 and the execution of the Master Agreement will enable the City to request reimbursement of eligible costs from the State is required before reimbursement.

ALTERNATIVES:

Not execute this agreement. This is not recommended because the City will be unable to request reimbursement for eligible work, and the City will be ineligible to participate in funding programs administered by Caltrans.

CITY COUNCIL GOALS:

- Excellent Infrastructure

CONCLUSIONS:

At its meeting of October 04, 2016, the Salinas City Council is requested to adopt a resolution authorizing the Mayor or the City Manager to execute Master Agreement with the State of California for administering transportation projects funded with Federal funds.
