**A RESOLUTION OF THE SALINAS CITY COUNCIL AUTHORIZING THE CITY MANAGER TO ENTER INTO AGREEMENTS FOR PROFESSIONAL SERVICES WITH RAIMI + ASSOCIATES, INC, LOCAL GOVERNMENT COMMISSION, THE ACTION COUNCIL AND APPLIED DEVELOPMENT ECONOMICS TO PREPARE A COMPLETE STREETS PLAN FOR EAST ALISAL UNDER THE CALTRANS SUSTAINABLE COMMUNITIES GRANT**

**WHEREAS**, the City partnered with the Local Government Commission (LGC), and Building Healthy Communities (BHC) to submit a Sustainable Communities Transportation Grant Application; and

**WHEREAS**, in June 2016, Caltrans awarded \$260,782 to the City to prepare a Complete Streets Plan (the “Plan”) for East Alisal from Front Street to Barden Road; and

**WHEREAS**, the Plan will focus on identifying the mobility, safety and economic development needs of residents and businesses, and developing corresponding solutions; and

**WHEREAS**, the final product will be a Plan for making the 4-mile corridor along East Alisal a Complete Street that works for all residents of Salinas, and is technically feasible and implementable by government agencies, businesses and the community; and

**WHEREAS**, the Plan will be incorporated into the Alisal Vibrancy Plan (AVP) and will follow the AVP two year planning process; and

**WHEREAS**, in July 2016, the City Council authorized the City Manager and City Attorney to enter into an Agreement with Raimi + Associates to prepare the Alisal Vibrancy Plan; and

**WHEREAS**, Caltrans approved the City moving forward with Raimi as the Complete Streets Plan consultant versus undertaking a separate selection process in order that community engagement and planning efforts of the Complete Streets and Vibrancy Plan not duplicate efforts.

**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SALINAS** the City Manager is authorized to:

1. enter into an agreement for professional services with Raimi + Associates, Inc (Raimi) for One Hundred Fifty -Two Thousand Three Hundred Dollars (\$152,300);
2. enter into an agreement for professional services with Local Government Commission, (LGC) for ~~Fifty-Two~~ Three Thousand ~~Nine Seven~~ Twenty Sixty Dollars (~~\$52,920~~ 53,760);
3. enter into an agreement for professional services with the Action Council for Twenty-One Thousand Nine Hundred Fifty Dollars (\$21,950); and
4. enter into an agreement for professional services with Applied Development Economics (ADE) for Thirty-Four Thousand Seven Hundred Ninety Dollars (\$34,790).

The Caltrans Grant award of \$260,782 will be the funding source for the Raimi, LGC and Action Council agreements. \$14,400 of the ADE agreement will be paid by the Caltrans Grant, with CIP 9247: EDE Implementation covering the contract balance of \$20,390.
