

**RESOLUTION NO. \_\_\_\_\_ (N.C.S.)**

**A RESOLUTION APPROVING THE REVISION OF SEVERAL STANDARD PLANS OF THE  
2008 EDITION OF THE CITY OF SALINAS STANDARD SPECIFICATIONS, DESIGN  
STANDARDS, AND STANDARD PLANS FOR THE CONSTRUCTION OF PEDESTRIAN  
RAMPS WITH THE CURRENT CALTRANS ADA STANDARD PLANS**

**WHEREAS**, on October 21, 2008, the City Council, pursuant to the provisions of Resolution No.19556 (N.C.S.), adopted the City of Salinas 2008 Edition of the City of Salinas Standard Specifications, Design Standards, and Standard Plans that provide the design requirements for the construction of public improvements/facilities within the City of Salinas; and

**WHEREAS**, pursuant to Salinas City Code Section 2-53, the City Council is authorized to adopt standard specifications, design standards, and standard plans for construction of public works facilities in the City by resolution; and

**WHEREAS**, several revised City of Salinas Standard Plans 2, 42 and 44 have been renamed as 2R, 42R and 44R respectively and has been submitted to the Salinas City Council for consideration pursuant to Section 2-53, and

**WHEREAS**, copies of the draft revised plans were reviewed by ADA consultant Sally Swanson Architects and several local contractors to ensure meeting all current ADA regulations.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF SALINAS:**

1. Standard Plans 2, 42 and 44 are replaced by Standard Plans 2R, 42R and 44R and are hereby adopted for the construction of public improvements and facilities within the City of Salinas and shall be part of the 2008 Edition of the City of Salinas Standard Specifications, Design Standards, and Standard Plans; and
2. Standard Plans No. 4A and 4B are deleted from the current City and Salinas Standards and replaced by Caltrans' latest ADA pedestrian ramp Standard Plans; and
3. The revised Standard Plans mentioned above, shall become effective and shall be in full force and effect on March 7, 2017 and applicable to all new public improvements and facilities projects, as therein defined, except as follows:
  - a. Projects for which a building permit, encroachment permit or similar permit has been issued prior to the date of this Resolution; and
  - b. Projects which are the subject of a vested subdivision map; and
  - c. Projects for which a planning level application has been received by the City of Salinas and said application has either been approved or deemed complete as of the date of this Resolution.
