**A RESOLUTION OF THE SALINAS CITY COUNCIL ACCEPTING A \$40,000 GRANT FOR THE BRIDGE PREVENTIVE MAINTENANCE PLAN FOR CITY BRIDGES FROM THE FEDERAL HIGHWAY ADMINISTRATION (FHWA) HIGHWAY BRIDGE PROGRAM FUNDS AND AUTHORIZING THE DIRECTOR OF PUBLIC WORKS TO EXECUTE FUNDING AGREEMENTS WITH THE STATE OF CALIFORNIA REQUIRED BY CALTRANS FOR THE BRIDGE PREVENTATIVE AND MAINTENANCE PLAN AND PROJECTS PROGRAM**

**WHEREAS**, the City actively seeks funding to supplement local funds for transportation infrastructure improvements; and

**WHEREAS**, the City was notified by the State Department of Transportation that the City has been granted a \$40,000 grant to prepare the Bridge Preventative Maintenance Plan (BPMP) to track and improve routine and preventative maintenance needs of the City's 15 Bridges, and eligible to receive funding necessary for long term capital improvements for rehabilitation and replacement of the City Bridges; and

**WHEREAS**, the BPMP will be a part of a maintenance and replacement program administered through Caltrans to assist in acquiring funding for the repairs and replacements needed; and

**WHEREAS**, FHWA will fund the plan and future projects with an 11.47% local matching funds; and

**WHEREAS**, the grant program requires a Resolution by the Council stating the title of the person authorized to enter into a contract with Caltrans and clearly identifying the project name related to said grant; and

**WHEREAS**, Council Resolution 17926, dated June 4, 2002 authorized the Public Works Director to execute future funding agreements with the State of California on Council approved grants.

**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SALINAS** that the City accepts the \$40,000 grant from Cal-Trans to write the Bridge Preventative Maintenance Plan for City bridges, and directs staff to implement this project and take whatever additional action may be necessary to implement the intent of this Resolution.

**BE IT FURTHER RESOLVED BY THE COUNCIL OF THE CITY OF SALINAS** that, it re-affirms Resolution 17926, authorizing the Public Works Director to execute agreements with the State Department of Transportation (Caltrans) related to the Bridge Preventative Maintenance Plan Grant awarded to and accepted by the City Council and to take whatever additional action is necessary to effectuate the intent of this Resolution.
