**WHEREAS**, the Planning Commission has confirmed that the report is not a project as defined by CEQA Guidelines Section 15378 and, therefore, no environmental assessment is required; and

**WHEREAS,** on March 1, 2017, the Planning Commission held a public meeting and reviewed the 2016 annual report.

NOW, THEREFORE, BE IT RESOLVED BY THE SALINAS PLANNING COMMISSION that the Planning Commission hereby approves the Annual Housing Element Progress Report for 2016 (Exhibit A) and finds that the report accurately reflects the City's progress in implementing the Housing Element; and

NOW, THEREFORE, BE IT FURTHER RESOLVED by the Salinas Planning Commission that the Commission recommends that the Salinas City Council approve the Housing Element Annual Progress Report for 2016 and direct staff to submit the subject document to the State of California Department of Housing and Community Development and the Governor's Office of Research as required by statute.
