Attached, please find an updated petition from a majority of the residents on Alameda Avenue (between Abbott Street and Grove Street) requesting that our area **remain on OPT OUT status** in regards to the District 3A Residential Permit Parking Program.

Since opting out of the Parking Program in August of 2012 (Please see a copy of the Public Hearing Notice dated August 14, 2012), there have been several new neighbors who have moved in that had no prior knowledge of the permit program. When approached to opt back in, they were not notified there was an annual fee for the parking permits. They signed thinking that it was at no cost to them.
