## **ID#17-206** Salinas Valley Recycles FY 2017-2018 Budget Report

Received report from Patrick Mathews, Salinas Valley Recycles (SVR) Executive Director, highlighting SVR FY 2017-18 operating budget of \$18,360,000. SVR is proposing an operating budget increase of 3.5% (\$572,000) to cover payroll increases, new C&D driver, new diversion worker, debt services and other increases. It is anticipated SVR will generate a total of \$619,150 (3.5%) revenue as a result of increased solid waste tonnage, AB 939 program funding, and franchise transportation surcharge. Mr. Mathews added SVR's FY 2017-18 rate adjustment for Salinas request is 1.7%-2.4% respectively.
