I. OVERVIEW

A. Introduction

The City of Salinas (“City”) annually levies and collects special assessments in order to maintain the improvements within the North/East Area Maintenance District Landscaping Assessment District 88-3 (“District”). The District is levied annually pursuant to *Article II, Chapter 21C of the Salinas City Code* and the *Landscaping and Lighting Act of 1972, Part 2 of Division 15 of the California Streets and Highways Code* (the “1972 Act”).

This Engineer’s Annual Levy Report (“Report”) describes the District, any changes to the District and the proposed assessments for Fiscal Year 2017/2018 (“Current Fiscal Year”). The proposed assessments are based on the historical and estimated costs to maintain the improvements within the District. The various improvements within the District and the costs of those improvements are identified and budgeted separately, including all expenditures, deficits, surpluses, revenues, and reserves. Each parcel is assessed proportionately for those improvements provided which the parcel receives benefit.

The word “parcel,” for the purposes of this Report, refers to an individual property assigned its own Assessment Number (Assessor Parcel Number) by the Monterey County Assessor’s Office. The Monterey County Auditor/Controller uses Assessment Numbers and specific Fund Numbers to identify on the tax roll, properties assessed for special district benefit assessments.

At a noticed Public Hearing, the City Council will consider all public comments and written protests presented. Upon conclusion of the Public Hearing, the City Council will tabulate property owner protest ballots received (for any proposed new or increased assessments) to determine whether majority protest exists, and by resolution confirm the results of any such protest ballot tabulations. The City Council will direct any necessary modifications to the Report and approve the Report as submitted or amended. There are no new or increased base assessment rates or annexations proposed for Fiscal Year 2017/2018.

Following approval of the Report, the City Council will by resolution, order the improvements to be made, any annexations of territory, and confirm the levy and collection of assessments pursuant to the 1972 Act. The assessments as approved will be submitted to the Monterey County Auditor/Controller to be included on the property tax roll for each parcel.

B. Historical Background and Current Legislation

The District has been formed pursuant to *Article II, Chapter 21C of the Salinas City Code* and the 1972 Act. Pursuant to the 1972 Act, the City Council annually conducts a public hearing to accept property owner and public comments and testimony, to review the Engineer's Report and approve the annual assessments to be levied on the County tax roll for the fiscal year. All assessments approved by the City Council have been prepared in accordance with the 1972 Act and are in full compliance with the provisions of the California Constitutional Article XIID ("Article XIID"), which was made part of the California Constitution with the passage of state-wide Proposition 218 in 1996.

In Fiscal Year 1999/2000, the City initiated and conducted property owner protest ballot proceedings for existing properties in compliance with the substantive and procedural requirements of Article XIID Section 4. At the conclusion of the Public Hearing, all property owner ballots returned were tabulated to determine if majority protest existed. The tabulation of the ballots indicated that majority protest did not exist. Therefore, the property owners approved the District's special benefit assessment and assessment range formula using an annual inflationary factor for maintaining the improvements.

The proposed assessment for the current fiscal year may be less than or equal to the maximum assessment rate previously approved for the District. Any proposed assessment that exceeds the maximum assessment rate requires property owner ballot proceedings for the incremental assessment increase. The actual assessment amount approved by each property owner will often vary as a function of their land use and proportionate special benefit; however, the actual assessment amount approved by the property owners is the maximum assessment rate applicable to the properties and improvements in that District. The benefit and apportionment of the maximum assessment rate is discussed in more detail in the Method of Apportionment Section of this Report.

The Method of Apportionment described in this Report utilizes commonly accepted assessment engineering practices and has been established pursuant to the 1972 Act and the provisions of Article XIID. All new or increased assessments will be subject to the substantive and procedural requirements of Article XIID Section 4.

C. General Description of the District and Services

The District provides the maintenance and operation of any or all public landscaping and irrigation improvements on landscaped median islands within the District boundaries. This includes 30-foot wide park strips of land adjacent to curbs of the streets described in Section II of this report, including cul-de-sac median islands, jogging paths, planter walls, Gabilan Creek and Natividad Creek channel improvements including outlet structures, riprap, retention ponds and bank protection, and bridge; appurtenant water mains and irrigation systems. Ornamental water, electric current, spraying, care, supervision, debris removal and any and all other items of work necessary and incidental for the proper maintenance and operation of the District are also included. Any incidental costs including contingencies, design engineering, and assessment collection costs, legal fees, administration and supervision are assessed to the District in the same way as the improvements listed above.

D. Improvements Authorized by the 1972 Act

As applicable or may be applicable to this proposed District, the 1972 Act defines improvements to mean one or any combination of the following:

- The installation or planting of landscaping.
- The installation or construction of statuary, fountains, and other ornamental structures and facilities.
- The installation or construction of public lighting facilities.
- The installation or construction of any facilities which are appurtenant to any of the foregoing or which are necessary or convenient for the maintenance or servicing thereof, including, but not limited to, grading, clearing, removal of debris, the installation or construction of curbs, gutters, walls, sidewalks, or paving, or water, irrigation, drainage, or electrical facilities.
- The maintenance or servicing, or both, of any of the foregoing.
- The acquisition of any existing improvement otherwise authorized pursuant to this section.

Incidental expenses associated with the improvements including, but not limited to:

- The cost of preparation of the report, including plans, specifications, estimates, diagram, and assessment;
- The costs of printing, advertising, and the publishing, posting and mailing of notices;
- Compensation payable to the County for collection of assessments;
- Compensation of any engineer or attorney employed to render services;
- Any other expenses incidental to the construction, installation, or maintenance and servicing of the improvements;
- Any expenses incidental to the issuance of bonds or notes pursuant to Section 22662.5.

- Costs associated with any elections held for the approval of a new or increased assessment.

The 1972 Act defines "Maintain" or "maintenance" to mean furnishing of services and materials for the ordinary and usual maintenance, operation, and servicing of any improvement, including:

- Repair, removal, or replacement of all or any part of any improvement.
- Providing for the life, growth, health, and beauty of landscaping, including cultivation, irrigation, trimming, spraying, fertilizing, or treating for disease or injury.
- The removal of trimmings, rubbish, debris, and other solid waste.
- The cleaning, sandblasting, and painting of walls and other improvements to remove or cover graffiti.

II. DESCRIPTION OF THE DISTRICT IMPROVEMENTS

The District is bounded on the west by a line approximately 1,300 feet easterly of Natividad Road, on the east by Williams Road, on the north by Boronda Road, and on the south by East Laurel Drive.

The following areas, along with specific improvements and maintenance done in that area are as follows. This maintenance, servicing and operation is in accordance with NPDES requirements of the City of Salinas stormwater permit.

Constitution Boulevard median island and appurtenant strip of land approximately 30 feet in width from face of east and west curb lines including planter walls from East Laurel Drive northerly 10,100 feet more or less to Boronda Road;

Independence Boulevard median island and appurtenant strip of land approximately 30 feet in width measured from face of curb along east and west curb lines to planter walls, including planter walls from Constitution Boulevard northerly 5,700 feet more or less to Boronda Road;

Gabilan Creek right-of-way approximately 100 feet in width more or less from a line approximately 3,800 feet more or less northerly of East Laurel Drive, thence 9,200 feet more or less northerly to Boronda Road;

Nantucket Boulevard including appurtenant strip of land approximately 30 feet in width measured from face of curb along north and south curb lines to and including adjacent planter walls from Independence Boulevard easterly to Constitution Boulevard;

Boronda Road median islands and appurtenant strip of land approximately 30 feet in width along north and south curb line measured from face of curb including planter walls from Natividad Road easterly 14,500 feet more or less to Williams Road;

Freedom Parkway median island and appurtenant strip of land approximately 30 feet in width along north and south curb line including planter walls from Constitution Boulevard easterly 6,800 feet more or less to Williams Road;

Nogal Drive from a line 800 feet south of Freedom Parkway north 1,400 linear feet more or less including appurtenant strips of land approximately 30 feet in width along the east and west curb line to street terminus;

Rider Avenue including appurtenant strips of land approximately 30 feet in width more or less along east and west curb line from a location approximately 1,200 linear feet south of Freedom Parkway northerly 3,700 feet more or less to Boronda Road including appurtenant planter walls;

North Sanborn Road including median island and appurtenant strips of land approximately 30 feet in width including planter walls from a line approximately 1,900 feet

south of Freedom Parkway northerly 3,700 feet more or less to Boronda Road including planter walls;

Towt Street from Freedom Parkway westerly 900 linear feet more or less to Mae Avenue including appurtenant strips of land approximately 30 feet in width from curb line east and west side of roadway including appurtenant planter walls;

Williams Road from a line approximately 1,300 feet south of Freedom Parkway northerly 3,500 linear feet more or less to Boronda Road including median islands and 30-foot side strip of land along west curb line including appurtenant planter wall;

Open Space includes the storm water detention facility, open space bluff and sloping ground areas including all open space easement areas, which have been landscaped and granted to the City of Salinas a permanent open space easement;

Tower Line Right-of-Way includes PG&E tower line right-of-way from approximately Constitution Boulevard to Boronda Road subsequent to landscaping and granting of open space easement to City of Salinas over lands for public use.

III. METHOD OF APPORTIONMENT

The District is assessed on the basis of total development units generated, for the maintenance and operation of the landscaping and irrigation improvements including incidentals and appurtenances and shall include all the costs of the improvements described herein.

The method of apportionment (method of assessment) is based on the premise that each assessed parcel receives a distinct and special benefit from the improvements maintained and funded by the assessments. The desirability of properties within the District is enhanced by the presence of well-maintained landscaping in close proximity to those properties.

The improvements generally include landscaped medians, parkways, entryways, slopes and appurtenant facilities. The annual assessments outlined in this Report are based on the estimated costs to provide all necessary service, operation, administration, and maintenance required each year to keep these improvements in a healthy, vigorous, and satisfactory condition and benefit the properties.

A. Proposition 218 Benefit Analysis

In conjunction with the provisions of the 1972 Act, the California Constitution Article XIID addresses several key criteria for the levy of assessments, notably:

Article XIID Section 2d defines District as follows:

“District means an area determined by an agency to contain all parcels which will receive a special benefit from a proposed public improvement or property-related service”;

Article XIID Section 2i defines Special Benefit as follows:

“Special benefit” means a particular and distinct benefit over and above general benefits conferred on real property located in the district or to the public at large. General enhancement of property value does not constitute “special benefit.”

Article XIID Section 4a defines proportional special benefit assessments as follows:

“An agency which proposes to levy an assessment shall identify all parcels which will have a special benefit conferred upon them and upon which an assessment will be imposed. The proportionate special benefit derived by each identified parcel shall be determined in relationship to the entirety of the capital cost of a public improvement, the maintenance and operation expenses of a public improvement, or the cost of the property related service being provided. No assessment shall be imposed on any parcel which exceeds the reasonable cost of the proportional special benefit conferred on that parcel.”

This District was formed to establish and provide for the improvements that enhance the presentation of the surrounding properties and developments. These improvements will directly benefit the parcels to be assessed within the District. The assessments and method of apportionment is based on the premise that the assessments will be used to construct and install landscape and lighting improvements within the existing North/East Area Maintenance District as well as provide for the annual maintenance of those improvements, and the assessment revenues generated by District will be used solely for such purposes.

The costs of the proposed improvements have been identified and allocated to properties within the District based on special benefit. The improvements to be provided by this District and for which properties will be assessed have been identified as an essential component and local amenity that provides a direct reflection and extension of the properties within the District which the property owners and residents have expressed a high level of support.

The method of apportionment (method of assessment) set forth in the Report is based on the premise that each assessed property receives special benefits from the landscape and lighting improvements within the District, and the assessment obligation for each parcel reflects that parcel's proportional special benefits as compared to other properties that receive special benefits.

To identify and determine the proportional special benefit to each parcel within the District, it is necessary to consider the entire scope of the improvements provided as well as the properties that benefit from those improvements. The improvements and the associated costs described in this Report, have been carefully reviewed and have been identified and allocated based on a benefit rationale and calculations that proportionally allocate the net cost of only those improvements determined to be of special benefit to properties within the District. The various public improvements and the associated costs have been identified as either "general benefit" (not assessed) or "special benefit".

General Rules

1. All costs associated with the maintenance and operation of the landscaping and irrigation improvements including the Engineer's Report, printing and mailing legal assessment notices, County collection fees and legal fees and appurtenances shall be spread to all developed and undeveloped parcels on a pro-rata area development unit basis as follows:

Developed and undeveloped parcels are those parcels on which roadway and public street improvements have been completed or bonded on which a final map has been filed as of the January 1st date prior to commencement of the Current Fiscal Year. Said parcels are also abutting a landscaped arterial or obtain access from a local street system which connects a landscaped arterial within the assessment district boundary.

2. Factored development unit calculations for developed and undeveloped residential and future school areas are shown in the following table:

Parcels Zoned or Developed High Density Residential	= 0.4 Units	Density of 16 to 22 units per net acre.
Parcels Zoned or Developed Medium Density Residential	=0.6 Units	Density of 6 to 15 units per net acre.
Parcels Zoned or Developed Low Density Residential	=1.0 Units	Density for lot size 5,200 to 6,500 square feet with maximum of 1 developed unit per lot.

3. Density for undeveloped parcels is based on approved tentative map or on basis of maximum allowable units per net acre if no tentative map has been filed.
- Office, firehouse, school, and commercial use are assessed based on a 32% floor area ratio (F.A.R.) using the net parcel area. The resulting floor area is divided into "equivalent" development units based on 4,000 square feet per unit.
 - Schools and other government buildings are assessed in accordance with 3a.
4. All assessed parcels shall be assessed an additional \$10.00 for the City's collection fee.
5. Parcels owned by the City of Salinas or any governmental agency are assessed.
6. Proposed and existing community open space or neighborhood parklands are not assessed.
7. Open space, creek, flood control or utility easement parcels not developable are not assessed.
8. Common area parcels within condominium developments are not assessed, as unit assessment allows for this use.
9. Parcels that develop in excess of the number of units assessed herein shall be required to pay for the additional units at the rates in effect at the time of development.
10. Since 1999, the cost per lot was indexed based on the *Engineering News Record's* cost index using 1999 as the base year. The cost increased each year based on the average of the common labor and materials costs in the *Engineering News Record's* April issue. In Fiscal Year 2016/2017, the cost per lot was indexed based on the Consumer Price Index ("CPI"). The City computed the percentage difference between the CPI on April for the most recent year-end and the CPI for the previous April as determined by the Bureau of Labor

Statistics for the San Francisco Oakland San Jose Area. Beginning Fiscal Year 2017/18, the cost per lot will be indexed based on the *Engineering News Record's* cost index. The cost increase is based on the average of the common labor and materials costs for San Francisco per the *ENR'S Cost Indexes by City* in the *Construction Economics* April Issue.

The table below shows the prior year's maximum assessment rate with the annual escalator, followed by the current year rates.

Note: In addition to the assessment rate shown, \$10 per parcel is added to cover a portion of the City administration costs.

IV. DISTRICT BUDGET

A. Description of Budget Items

The following describes the services and costs that are funded through the District, shown in the District Budget table in part B of this section.

DIRECT COSTS:

Maintenance Services — All labor, material and equipment required to properly maintain the landscaping, irrigation systems, drainage systems, water features and ornamental lighting systems within the District

In-House Inspection — Costs related to Inspectors on City staff who provide services such as construction work monitoring, project documentation, inspection and testing during the construction phase of a project

Contingencies — This is a fund for additional costs of repairs that are unforeseen and not normally included in the yearly maintenance cost. This may include repair of damaged amenities due to vandalism, storms, frost and planned upgrades of the improvements including all renovation costs. Examples of upgrades are replacement of plant materials and/or renovation of irrigation or ornamental lighting systems.

Utilities — The furnishing of electricity and water required for the operation and maintenance of landscaping facilities including ornamental lighting and irrigation facilities.

ADMINISTRATION COSTS:

Agency Administrative Expenses — The cost to all particular departments and staff of the City for providing the coordination for District service, operations and maintenance, responding to public concerns and education, and levy collection. This is the cost to the District for any additional administrative expenses not normally included in the yearly administration costs including, but not limited to the cost of preparing, producing and/or mailing any notices, ballots, assessment hand bills, or tax roll changes and may also include the costs of resource materials or any other administrative expense or fees associated with the District.

Professional Fees — The costs of contracting with professionals to provide services specific to the levy administration and any additional administrative, legal or engineering services specific to the District.

City Collection Fee — This is the cost to the District for the County and City to collect District assessments on the property tax bills. This charge is based on the flat rate of \$10 per parcel.

CAPITAL IMPROVEMENT PROJECT:

Capital Improvements Expenses — This item represents the planned expansions or improvements within the District for Fiscal Year 2017/18. Currently, there are no planned capital improvement expenses for Fiscal Year 2017/18.

LEVY BREAKDOWN:

Total Direct, Admin. And Capital Improvement Costs — This amount represents the sum total of all Direct, Administration and Capital Improvement Costs for Fiscal Year 2017/18.

Operating Reserve Collection — This line item reflects funds being added to, Collection, or provided by, the Reserve Fund Account for the current fiscal year. The Reserve Account provides funds to operate the District from the time period of July 1 (beginning of the fiscal year) through December when the County provides the City with the first installment of assessments collected from the property tax bills. The Reserve Account eliminates the need for the City to transfer funds from non-district accounts to pay for District charges during the first six (6) months of the fiscal year.

Capital Reserve Collection — This item allows the District to collect a portion of the total cost of a major improvement over several years thus reducing the short-term financial impact to the property owners.

LEVY ADJUSTMENTS:

Operating Reserve Contribution — This item reflects the amount of the current operating reserve that will be used towards direct costs in the current year.

Capital Reserve Contribution — This item reflects the amount of the current capital reserve that will be used towards the cost of a major improvement in the current year.

Additional City Contribution — This is the amount of additional funds provided by the City. These funds are used to supplement the current year's levy.

Estimated Interest Earnings — This is the estimated amount of interest earned on the Reserve fund to be used toward the Levy.

Balance to Levy — This is the total amount to be levied against the parcels within the District and Zone for the current fiscal year. The Balance to Levy represents the Levy Breakdown Sub-Total minus the Levy Adjustments Sub-Total. This dollar amount represents the funds that are to be collected for the current Fiscal Year from the property owners through assessments.

DISTRICT STATISTICS:

Total Parcels Levied — This is the total number of parcels within the District that will be assessed for the current fiscal year. Non-assessable lots or parcels may include government owned land, public utility owned property, land principally encumbered by public right-of-ways or easements, common areas, and/or parcels within the boundaries of the District or Zone that currently do not benefit from the improvements due possibly to development restrictions.



Non-assessable lots or parcels include areas of public streets and other roadways (typically not assigned an APN by the County); dedicated public easements, open space areas and rights-of-ways including public greenbelts and parkways; utility rights-of-ways; common areas (such as in condominium complexes); landlocked parcels, small parcels vacated by the County, bifurcated lots, and any other property that cannot be developed; and park properties and other publicly owned, government-owned, public utility-owned properties that have little or no improvement value. These types of parcels are considered to receive little or no benefit from the improvements and are therefore exempted from assessment.

At the conclusion of the public hearing for the District and the proposed assessments, any property owner assessment ballots for new or increased assessments will be tabulated for all ballots returned, and the City Council will declare the result of any such balloting. Based on balloting results (if any), the City Council may amend this Report or approve the Report as submitted. Approval of the Report (as submitted or as modified) confirms the method of apportionment and the maximum assessment rate to be levied against each eligible parcel and thereby constitutes the approved levy and collection of assessments for Fiscal Year 2017/2018. The listing of parcels and the amount of assessment to be levied shall be submitted to the County Auditor/Controller and included on the property tax roll for each parcel in Fiscal Year 2017/2018.

If any parcel submitted for collection is identified by the County Auditor/Controller to be an invalid parcel number for the current fiscal year, a corrected parcel number and/or new parcel numbers will be identified and resubmitted to the County Auditor/Controller. The assessment amount to be levied and collected for the resubmitted parcel or parcels shall be based on the method of apportionment and assessment rate approved in this Report. Therefore, if a single parcel has changed to multiple parcels, the assessment amount applied to each of the new parcels shall be recalculated and applied according to the approved method of apportionment and assessment rate rather than a proportionate share of the original assessment.
