RESOLUTION NO. (N.C.S.)

A RESOLUTION OF THE SALINAS CITY COUNCIL TO MODIFY FUNDING ALLOCATIONS FOR THE FY 2017-2018 ADDITIONAL ENTITLEMENT EMERGENCY SOLUTIONS GRANT (ESG) FUNDING ALLOCATION FROM U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD)

WHEREAS, on September 19, 2017, the Salinas City Council adopted Resolution No. 21259 (N.C.S.) approving the allocation of \$274,641 in additional Entitlement ESG funding for FY 2017-2018; and

WHEREAS, at its meeting on September 19, 2017, the City Council approved a plan to utilize \$240,000 of the additional ESG allocation of \$274,641 to support operations of a 2017-2018 winter warming shelter currently proposed for operation no sooner than November 1, 2017 through May 31, 2018 at 111 W. Alisal Street in Salinas in partnership with the County of Monterey; and

WHEREAS, the City intended to use the remaining \$34,641 in ESG funding for administrative costs and work related to the establishment of a permanent year-round homeless shelter currently proposed to be located at 1220 Natividad Road in Salinas; and

WHEREAS, ESG regulations limit the amount of funding to be used for administrative purposes to no more than 7.5%, and further limit funding allocation to no more than 60% towards the Street Outreach and Emergency Shelter as defined by HUD; and

WHEREAS, the City intends to allocate a total of \$20,598 out of the \$274,641 of additional ESG funding allocated for FY 2017-2018 for administrative purposes, this being less than the 7.5% mandated by ESG regulations; and

WHEREAS, the remaining \$254,043 will be utilized to support operations of a 2017-2018 winter warming shelter currently proposed for operation no sooner than November 1, 2017 through May 31, 2018 at 111 W. Alisal Street in Salinas in partnership with the County of Monterey; and

WHEREAS, out of the \$254,043 allocated for the 2017-2018 warming shelter, no more than \$164,780 can be used for Street Outreach and Emergency Shelter purposes as mandated by ESG regulations, and the remaining \$89,263 can be utilized for the Homeless Prevention, Rapid Re-Housing, and Homeless Management Information System (HMIS) components of the ESG program; and

WHEREAS, the City will continue to work in partnership with the County of Monterey to establish a permanent year-round homeless shelter currently proposed to be located at 1220 Natividad Road in Salinas.

NOW, THEREFORE, BE IT RESOLVED that the Salinas City Council hereby approves the proposed modification to the ESG allocations originally approved on September 19, 2017.
