## A RESOLUTION APPROVING PLANS AND SPECIFICATIONS AND DIRECTING NOTICE TO BIDDERS FOR THE SALINAS MUNICIPAL AIRPORT RUNWAY 13-31 AND RUNWAY 8-26 REHABILITATION; CIP NO. 9275 (FAA AIP NO. 3-06-0206-27)

**WHEREAS,** on June 6, 2017, by way of resolution 21178, City Council authorized the acceptance of grant funds from the FAA (AIP 26) for engineering and design services for airport pavement rehabilitation, City Project No. 9276; and

**WHEREAS,** on November 28, 2017, by way of resolution 21300, City Council approved the transmittal of the Airport Capital Improvement Program (ACIP) submittal to the FAA. This ACIP submittal included Runway 13-31 and Runway 8-26 as the City of Salinas' highest priority for grant application and funding; and

**WHEREAS,** on January 9, 2018 City Council approved Resolution 2135 authorizing the submittal of a grant application and acceptance of grant offer from the FAA and CalTrans Division of Aeronautics for the rehabilitation of Runway 13-31 and 8-26 (AIP 27), City Project No. 9275; and

WHEREAS, the certain document entitled Salinas Municipal Airport Runway 13-31 and Runway 8-26 Rehabilitation; FAA AIP No. 3-06-0206-27 City Project No.9275 was filed at the office of the City Clerk of Salinas on March 20, 2018; and

WHEREAS, bids for said work shall be received at the office of the City Clerk at City Hall, 200 Lincoln Avenue, Salinas, California, until two o'clock p.m. on the 24th day of April 2018, and that a public meeting shall be held in the City of Salinas Rotunda, Salinas, California, on the 24th day of April 2018, at the hour of two o'clock p.m. of said day at which time and place all of said bids for proposals shall be publicly opened, examined, and declared by said City Clerk, or his/her designee, who shall thereupon report the results of the bidding to the Council of Salinas at a regular meeting of said Council after the opening of the bids; and

**WHEREAS,** the City Engineer is authorized to extend, revise, or set the bid opening date through an addendum as necessary to meet the required bidding schedule.

**NOW, THEREFORE, BE IT RESOLVED** the plans and specifications for Salinas Municipal Airport Runway 13-31 and Runway 8-26 Rehabilitation; FAA AIP No. 3-06-0206-27 City Project No.9275 are hereby adopted; and

**NOW, THEREFORE, BE IT FURTHER RESOLVED** that the City Clerk is hereby directed to publish notice to bidders inviting sealed proposals for said work for one time in a newspaper of general circulation as required under the law, which notice shall set forth the time and place, when and where bids shall be received, opened and read, and shall further refer to the aforesaid plans and specifications on file in the office of said City Clerk for the contents thereof.

It is not required that any other matters be set forth in said published notice to bidders. Said publication shall be completed at least 10 days before the 24th day of April 2018. No other notice shall be required.
