## A RESOLUTION OF THE SALINAS CITY COUNCIL APPROVING AND IMPLEMENTING THE FY 2018-19 UNITED STATES DEPARTEMNT OF HOUSING AND URBAN DEVELOPMENT (HUD) ACTION PLAN AND AUTHORIZING SUBMITTAL TO HUD

WHEREAS, the FY 2018-19 Action Plan (ACTION PLAN) is an annual statement of activities that will be undertaken in furtherance of the City's Consolidated Plan (CONPLAN) objectives for the period July 1, 2018 to June 30, 2019, and is required to be submitted to the United States Department of Housing and Urban Development (HUD); and

WHEREAS, the City Council conducted a public hearing on April 17, 2018 and May 1, 2018 and consulted with service providers, non-profit agencies, and other members of the community regarding both housing and community development needs and the City's CDBG/Housing Subcommittee; and

WHEREAS, the draft ACTION PLAN was made available for public review on the City's website, City Hall, the Community and Economic Development Department office, the three City libraries, and community input was solicited beginning March 26, 2018; and

WHEREAS, the City Council held duly-noticed public hearings on April 17, 2018 and May 1, 2018 to obtain further comments on the draft FY 2018-19 ACTION PLAN.

NOW, THEREFORE, BE IT RESOLVED THAT THE COUNCIL OF SALINAS hereby approves the FY 2018-19 ACTION PLAN and authorizes submittal to HUD on or before August 16, 2018.

BE IT FURTHER RESOLVED BY COUNCIL OF SLAINAS, that the Mayor or his designee is hereby authorized and directed, for and on behalf of the City of Salinas, and as its act and deed, to execute and file the aforementioned plans, and related Applications for Federal Assistance, including required Agreements, Contracts and Certifications with HUD.

BE IT FURTHER RESOLVED BY COUNCIL OF SALINAS, that the City Manager or his designee, is hereby authorized and directed, for and on behalf of the City of Salinas, to execute and file HUD Agreements, City Funding Agreements/Contracts and related documents (e.g., environmental documentation, and request for release of HUD funds) implementing the funding allocations set forth in the ACTION PLAN at such time as HUD submits said agreements to the City.
