TITLE: ALLIANCE ON AGING - SENIOR TRANSPORATION SERVICES

RECOMMENDED MOTION:

There is no recommended motion. Traffic and Transportation Commission is recommended to receive an informational presentation on Senior Transportation Services from Alliance on Aging.

BACKGROUND:

Alliance on Aging (AOA), a volunteer driven non-profit organization that provide support for seniors. AOA guide seniors toward transportation services and mobility options. It is also their charge to help ensure viability of programs for seniors in Monterey County.

Senior Transportation Specialist, Maribel Trejo, will provide a presentation on different transportation options for seniors living in Monterey County. AOA does not provide transportation services but serves as a hub of information on transportation for seniors. Maribel Trejo's presentation will also provide information on of how AOA can help community members apply for services and provide support for first-time senior Monterey- Salinas Transit (MST) riders.

CEQA CONSIDERATION

Not a Project. The City of Salinas has determined that the proposed action is not a project as defined by the California Environmental Quality Act (CEQA) (CEQA Guidelines Section 15378). In addition, CEQA Guidelines Section 15061 includes the general rule that CEQA applies only to activities which have the potential for causing a significant effect on the environment. Where it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment, the activity is not subject to CEQA. Because the proposed action and this matter have no potential to cause any effect on the environment, or because it falls within a category of activities excluded as projects pursuant to CEQA Guidelines section 15378, this matter is not a project. Because the matter does not cause a direct or foreseeable indirect physical change on or in the environment, this matter is not a project. Any subsequent discretionary projects resulting from this action will be assessed for CEQA applicability.

The Alliance on Aging Senior Transportation Coordination program relates to City Council's Strategic Plan "Quality of Life" by providing information and support to the senior community.
