**A RESOLUTION OF THE SALINAS CITY COUNCIL APPROVING THE REMOVAL
OF SPECIAL CURB MARKINGS AT 14 LOCATIONS AND ESTABLISHING THE
2018-2019 SPECIAL CURB MARKINGS LIST**

WHEREAS, business owners who have one or more special curb markings installed on the city right-of-way have either not responded to annual renewal notices or requested the removal for said markings to be removed pursuant to Salinas Municipal Code Section 20-74; and

WHEREAS, at its meeting of September 13, 2018, the Salinas Traffic and Transportation Commission unanimously recommended approval by a 5-0 vote to update the status of the 2018-2019 special curb markings by deleting fourteen (14) special curb markings; and

WHEREAS, at its February 9, 1970 meeting, City Council approved a Resolution 6993 establishing a list of special curb markings; and

WHEREAS, the 2018-2019 Special Curb Markings List attached includes a listing of current valid special curb markings and related amending Resolutions found amending said Resolution 6993; and

WHEREAS, to improve the efficiency and clarity of record for established curb markings, the City henceforth shall re-establish said list annually.

NOW, THEREFORE, BE IT RESOLVED that the Salinas City Council approves the 2018-2019 special curb marking deletions as follows:
