**A RESOLUTION OF THE SALINAS CITY COUNCIL  
APPROVING THE FY 2019-20 APPLICATION SUBMITTAL TO THE CALIFORNIA  
DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT FOR THE  
EMERGENCY SOLUTIONS GRANTS PROGRAM CONTINUUM OF CARE ALLOCATION  
NOTICE OF FUNDING AVAILABILITY**

**WHEREAS**, the City of Salinas (City) is the only City within Monterey and San Benito Counties that administers the California Department of Housing and Community Development (HCD) Emergency Solutions Grants (ESG) Program; and

**WHEREAS**, HCD approved the City to be the Administrative Entity (AE) for a period of two fiscal years (2018-19 and 2019-20) on behalf of the local Salinas/Monterey/San Benito Counties Continuum of Care (CoC) for the HCD ESG Program; and

**WHEREAS**, HCD issued an ESG CoC Allocation Notice of Funding Availability (NOFA) on March 29, 2019 which included an estimated funding formula allocation to the local CoC in the amount of \$280,598; and

**WHEREAS**, the HCD ESG CoC Allocation NOFA application submittal deadline is May 30, 2019; and

**WHEREAS**, the City intends to submit an HCD ESG CoC Allocation NOFA application in order to secure funding by no later than the application deadline of May 30, 2019; and

**WHEREAS**, should HCD increase the initial ESG CoC funding formula allocation to the local CoC, the City is hereby authorized and directed to receive an ESG grant, not to exceed \$600,000 in accordance with all HCD rules and laws; and

**WHEREAS**, the City hereby agrees to use ESG funds for eligible activities as approved by HCD and in accordance with all grant program requirements, and other rules and laws, as well as in a manner consistent and in compliance with the Standard Agreement and any other contracts between the City and HCD.

**NOW, THEREFORE, BE IT RESOLVED**, that the City Manager or his designee, is hereby authorized and directed, for and on behalf of the City, to submit the HCD ESG CoC Allocation NOFA application, execute the Standard Agreement and any subsequent amendments or modifications thereto, as well as any other documents which are related to the HCD ESG program, as HCD may deem appropriate.

**BE IT FURTHER RESOLVED BY COUNCIL OF SALINAS**, that the City Manager or his designee, is authorized and directed to execute, for and on behalf of the City of Salinas, City Funding Agreements/Contracts and related documents (e.g., environmental documentation, request for release of funds) in order to implement the HCD ESG Program.
