A RESOLUTION APPROVING BID AWARD AND EXECUTION OF CONTRACT TO AMERICAN ROAD MAINTENANCE FOR THE SALINAS MUNICIPAL AIRPORT RUNWAY 8-26 AND HELIPORT REHABILITATION; CIP NO. 9157 (FAA AIP NO. 3-06-0206-28) IN THE AMOUNT OF \$415,588.14

WHEREAS, on March 19, 2019, the City Council pursuant to Resolution No. 21578 (N.C.S.) approved plans and specifications for the Salinas Municipal Airport Runway 8-26 and Heliport Rehabilitation Project; CIP No. 9157 (FAA AIP No. 3-06-0206-28); and

WHEREAS, representatives of the City Clerk of Salinas on April 18, 2019, at a public meeting held in the Rotunda at Salinas City Hall, at Salinas, California, publicly opened, examined and declared all bids or proposals delivered to or filed with said City Clerk for the Salinas Municipal Airport Runway 8-26 and Heliport Rehabilitation Project; CIP No. 9157 (FAA AIP No. 3-06-0206-28) in accordance with the plans and specifications for such work filed in the office of said City Clerk on March 19, 2019, and now on file in said office; and

WHEREAS, the lowest bidder, American Road Maintenance, submitted a total bid that is less than half of the engineer's estimate, and sufficient funds are available to award the project; and

WHEREAS, City staff thereupon reported the results of the bidding to the City Council at its regular meeting on August 13, 2019, and the Council in open session at said meeting examined the report of staff;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL that pursuant to City Code Section 12-21, in reference to the Salinas Municipal Airport Runway 8-26 and Heliport Rehabilitation Project; CIP No. 9157 (FAA AIP No. 3-06-0206-28), that all of said bids or proposals are rejected except the bid of American Road Maintenance (hereinafter referred to as "The Successful Bidder"), being the lowest and best bid which is hereby accepted. The subject contract is hereby awarded to said Successful Bidder for the sum \$415,588.14, and more specifically at the unit prices particularly set forth and contained in the Proposal for the Salinas Municipal Airport Runway 8-26 and Heliport Rehabilitation Project; CIP No. 9157 (FAA AIP No. 3-06-0206-28), of said Successful bidder previously filed in the office of the City Clerk, on April 18, 2019. Said sum shall be paid by the City of Salinas to said Successful Bidder in cash, lawful money of the United States of America, payable at

the time and in the manner specified in the plans and specifications and contract documents for the project filed in the office of the City Clerk on March 19, 2019, entitled "Salinas Municipal Airport Runway 8-26 and Heliport Rehabilitation Project; CIP No. 9157 (FAA AIP No. 3-06-0206-28)".

BE IT FURTHER RESOLVED that said plans and specifications are hereby referred to for all of the details and particulars thereof, and said plans and specifications are by reference incorporated in and hereby made a part of this resolution.

BE IT FURTHER RESOLVED that the Mayor of Salinas is hereby authorized and directed on behalf of the City of Salinas to execute a contract consistent with the Proposal of said Successful Bidder for said work.
