**A RESOLUTION OF THE SALINAS CITY COUNCIL  
APPROVING THE FY 2018-19 CONSOLIDATED ANNUAL PERFORMANCE AND  
EVALUATION REPORT AND AUTHORIZING SUBMITTAL TO THE UNITED STATES  
DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT AND ACCEPTING  
COMMENTS ON HOUSING AND COMMUNITY DEVELOPMENT NEEDS**

**WHEREAS**, the FY 2018-19 Consolidated Annual Performance and Evaluation Report (CAPER) is an annual report describing eligible projects, programs and activities that were undertaken with United States Department of Housing and Urban Development (HUD) Community Development Block Grant (CDBG) Program, Home Investment Partnerships Program (HOME) and Emergency Solutions Grants (ESG) Program funds for the period of July 1, 2018 through June 30, 2019; and

**WHEREAS**, the FY 2018-19 CAPER summarizes the City of Salinas (City) progress in meeting the public service community development needs, affordable housing needs, needs of in relation to the 2015-19 Consolidated Plan (Con Plan) and FY 2018-19 Annual Action Plan (AAP) for activities carried out under CDBG, HOME, and ESG programs, and;

**WHEREAS**, in accordance with 24 CFR Part 91.105, the City is required to conduct a public hearing each year to obtain citizens' views on housing and community development needs; and

**WHEREAS**, HUD regulations in accordance with the City's adopted Citizen Participation Plan (CPP) requires a minimum fifteen (15) day CAPER public comment period; and

**WHEREAS**, the FY 2018-19 CAPER is due to HUD by September 28, 2019;

**WHEREAS**, a notice was published in The Californian and El Sol newspapers on August 24, 2019 announcing the minimum fifteen (15) day CAPER public comment period beginning August 24, 2019 through September 10, 2019; and the notice also advised the public of an upcoming public hearing at the City Council meeting scheduled for September 10, 2019; and the notice advised the public of a public hearing on housing and community development needs; and

**WHEREAS**, the City CDBG/Housing Committee conducted a public hearing regarding the FY 2018-19 CAPER on August 20, 2019.

**NOW, THEREFORE, BE IT RESOLVED** that the Salinas City Council hereby approves the FY 2018-19 CAPER and authorizes the submission to HUD and has accepted comments on housing and community development needs in a public hearing announced for that purpose; and

**BE IT FURTHER RESOLVED** that the Salinas City Council hereby authorizes the City Manager or his designee to execute, for and on behalf of the City and to submit to HUD the FY 2018-19 CAPER by September 28, 2019.
