 This report is a compilation of information from the different departments and staff who participated in the enforcement operations and public outreach campaigns. The information was gathered by the Salinas Fire Department (SFD), the Salinas Police Department (SPD), Salinas Code Enforcement Division (SCED), Salinas Public Works Department (SPW), and the Monterey County Emergency Communications Department (ECD).

 The issues addressed in this AAR are requested to be reviewed and thoroughly examined for the appropriation of needed resources to ensure the functions of incident response, stabilization and enforcement are safe, efficient and effective.



OUTREACH & EDUCATION

• Starting in June 1st, a multi-media campaign was launched to increase involvement from residents in the reporting of illegal fireworks use.

• Large signs were again placed at key intersections throughout the city.

• Social media, print press, and television news stories.


• A new strategy included the placement of public service announcements in movie theaters. Messages were displayed to moviegoers over 4000 times per week.

• Over 500 lawn signs were placed directly into neighborhoods. Additional signs were delivered to resident groups and made available to the public at City Hall and at the Council rotunda.

• This campaign proved ongoing success in routing complaints received to the <u>www.salinasfireworks.com</u> website, the "Salinas Connect" application, as well as the voicemail and text tip line.




OBSERVE & DOCUMENT



- Based on the lessons learned from the 2018 season, undercover patrols were deployed on July 4th exclusively and were equipped with video cameras in addition to dashboard cameras installed in their vehicles.
- The Salinas Police Department deployed Violence Suppression Unit officers undercover as well. Coordinating with Fire Prevention and Code Enforcement staff via the encrypted radio network, resources patrolled areas where increased activity was evident.
- Upon deployment, all units were provided with a list of addresses where illegal fireworks were witnessed and/or cited the previous year. Throughout the evening, fireworks activity in these areas had notably decreased and reports were scant, perhaps as evidence of the effectiveness of the previous years' enforcement efforts.

There was a marked decrease in fireworks use activity this year, most notably in the areas of Creekbridge and South Salinas.


FIRE DEPARTMENT OPERATIONS & STATISTICS

During this period in 2019, SFD responded to a total of 1,959 emergency incidents. A breakdown of the fire incidents with previous years' data is provided as follows:

FIRE DEPARTMENT OPERATIONS & STATISTICS

For the period of July 4th through July 6th the SFD staffed 1 additional apparatus with 3 personnel and 1 chief officer to respond to increased calls for service and patrol the target threat areas. The Salinas Police Department deployed 7 additional officers.

STRENGTHS

- Adequate Funding from existing fees, surcharges, and fines.
- Participation from the Code Enforcement Division and Public Works Departments helped to alleviate the excessive burden of limited SFD and SPD resources.
- Comprehensive media coverage to include social media, led to a significant increase in citizen-based tips from the "neighborhood approach".
- Undercover operations to "observe and report" led to Administrative Citations with better evidentiary support.
- Integration of the Salinas Connect reporting platform provided detailed information for follow-up.
- Movie theater ads were effective at promulgating information to the public.
- Advance warnings sent to addresses where illegal fireworks were reported last year helped to deter activity in certain areas.

AREAS OF IMPROVEMENT

- Participation from organized neighborhood and citizens' groups was solicited with little to no response or action.
- *Limited staff was physically available for patrols.*
- Collection and sorting of data from various sources of intelligence remains a manual process and is labor intensive.
- Manual review of video evidence is also time consuming and delays issuance of Administrative Citations.
- Quality of video and photo evidence in low light is challenging. Look into more technically capable equipment if possible.

RECOMMENDATIONS

- Continue attempts to engage neighborhood groups and citizens in "observe and report" roles and the distribution of signage.
- Increase publicity of undercover activity and citation statistics in traditional and social media.
- **Consider a "reward" system** for tips leading to successful citation of individuals and property owners where illegal fireworks are used. Rewards could be funded with successfully collected fines.
- *Re-consider "Social Host Ordinance".*
- Increase fines related to fireworks violations as a deterrent.

The goal of these programs continues to focus on changing social consciousness at the individual and neighborhood level. It should be acknowledged that this is an ongoing process over several years but marked decreases in activity were noted this year.

The decrease in activity and improvement in the quality of citizen-initiated reports is a positive indicator of the success of these efforts. The increase in citations with actionable evidence is another product of better collaboration between City departments in a coordinated fashion.

Future years' plans will build on these successes and the Council Fireworks Subcommittee and City staff will remain engaged with constituents to discuss and implement recommendations to bring about a social change and improve the quality of life for the residents of Salinas.
