
Mr James Serrano,

I live at the cross of Central Ave and West St. and I oppose the red curb no parking proposal for West/ Archer St. intersection. We already have a problem with finding parking in our area without losing more space. I have never had any safety issues driving that area for the last 20 years, there are other places I can think of that needs a red curb but that spot is not one of them.

I would support a proposal of a parking permit system like there is around the neighborhoods by Salinas Valley Memorial Hospital. Residents pay a yearly fee per car for a permit and are allowed to park on the street. Living on Central is a constant battle with the college kids and too many cars for the apartments around here. I work a lot of night shifts and usually have to park 2 blocks away from my home when I get off at 2 am. The permit system would force the college students to utilize the Hartnell parking lot, and maybe some of the excess vehicles left in our neighborhood. The college would receive money from the new cars using their parking lot, and the city would receive extra funds from the resident permits sold for other traffic needs.
