CANVASS OF JUNE 7, 2016 CONSOLIDATED SPECIAL MUNICIPAL ELECTION

WHEREAS, on February 9, 2016 the Salinas City Council adopted Resolution No. 20907 calling for the consolidation of the June 7, 2016 election asking the voters of the City of Salinas to consider an ordinance regulating the possession, use, storage, sale and display of fireworks, herein referred to as Measure C; and

WHEREAS, on February 23, 2016, the Salinas City Council adopted Resolution No. 20912 also calling for the consolidation of the June 7, 2016 election asking the voters of the City of Salinas to amend the City Charter, herein referred to as Measure B; and

WHEREAS, pursuant to California Elections Code section 9217, Measure C shall become a valid and binding ordinance of the City. The ordinance shall be considered as adopted upon the date that the vote is declared by the City Council, and shall go into effect ten days after; and

WHEREAS, pursuant to California Government Code Section 34459, Measure B shall be deemed ratified, but shall not take effect until accepted and filed by the Secretary of State pursuant to Section 34460.

WHEREAS, said municipal election was held on said date in accordance with law, the votes thereof received and canvassed, and the returns thereof ascertained, determined, and declared in all respects.

NOW, THEREFORE, the City Council declares that the number of votes cast for each Measure is as follows:

Measure B received a majority yes vote and therefore passes and is approved by the voters of Salinas.

Measure C received a majority yes vote and therefore passes and is approved by the voters of Salinas.

The "Certificate of the Registrar of Voters for the City of Salinas Election" held on June 7, 2016 is attached as Exhibit A and is incorporated in this resolution by reference.

BE IT FURTHER RESOLVED that the City Clerk is hereby authorized to certify and authenticate three copies of the complete text of a charter, by the chairperson and attested by the City Clerk, setting forth the submission of the charter to the voters of the city, and its ratification pursuant to Government Code Section 34460. One copy shall be recorded with the Monterey County Recorder, and one filed in the archives of the city. The third copy shall be filed with the Secretary of State. Each copy recorded with the Monterey County Recorder and filed in the archives of the city shall be filed with the following:

(a) Certified copies of all publications and notices required of the city by this chapter or by the laws of this state in connection with the calling of an election.

(b) Certified copies of any arguments for or against the charter amendment pursuant to Sections 9281 and 13303 of the Elections Code.

(c) A certified abstract of the vote at the election at which the charter amendment was approved by the voters.

BE IT FURTHER RESOLVED that the adoption of this resolution declaring the results of the June 7, 2016 election on Measure C shall also result in the adoption of Ordinance 2574 and will become effective ten (10) days after the City Council declares the results pursuant to Elections Code Section 9217.
