To whom it May Concern,

I am opposed to the request to opt-in to the district 3A Residential Permit Parking Program. Paraiso Court as a whole does not have a traffic/parking issue. From Monday through Friday, during traditional business hours, Paraiso Court does see an increase of nonresidents utilizing the street to park. The nonresident parking primarily occurs on the northern part of Paraiso Court located near the northern intersection with Via Paraiso Street. See picture 1A and 1B. This temporarily inconveniences residents 11, 12, 15, 19, 23 and 32. Resident 27 does not have space for curbside parking. Paraiso Court's southern portion which intersects with Via Paraiso Street sees minimal use by nonresidents (Anywhere between three to six cars). See picture 2A and 2B. Ironically, it mainly affects the corner resident property owners, whose physical address is Via Paraiso. The eastern section of Paraiso Court is unaffected by the alleged traffic/parking issue. See picture 3A. Resident 32, who have the longest property line on the northern section of Paraiso Court are also opposed to the request to opt-in to the district 3A Residential Permit Parking Program. Ironically, eight of the twelve residents that support the parking permit program, utilize their garage or driveway to park their personal vehicle(s) and as a result, will not experience any financial impact as a result of the program. In closing, I want to reiterate my objection to Paraiso Court opting in to the district 3A Residential Permit Parking Program.

I am writing this email to OPPOSE the parking permit proposal for Paraiso Court. I am a 21 year resident of the Paraiso Court neighborhood (32 Paraiso Court) and, although there has been a small increase in non-residential parking, it has NOT been a hinderance in any way.

My house is located on 8,000 square foot corner lot on the end of the street closest to the medical buildings near Salinas Valley Memorial and I have 2 driveways which have NEVER been blocked by non-residential cars. In fact, I am surprised by the claims that these non-residential cars have been blocking driveways. Most, if not all, of these cars belong to our frontline health workers who are risking their health by battling the pandemic and were referred to last year as "heroes".

I was made aware of a recent police incident involving drug dealing in the neighborhood. What you may not realize was the incident occurred at 3 am in the morning and I highly doubt that if we had a permit parking enforcement program in place that this unfortunate incident would have been prevented.

I would also like the committee to know that I do NOT have any problems with having any of my neighbor's friends or family park around my house which occurs on an almost daily occurrence. In fact, I let my neighbor's gardener use my driveway so it will be easier for him to unload and load his heavy gardening equipment because that's what neighbors are supposed to do, help each other.

I am writing to express my support for the petition by Paraiso Ct residents to opt into the District 3A Residential Permit Parking Program. My main concern is that for years now the street has been an unmarked parking lot for non-residents. Paraiso Court is one of the few remaining streets near the Los Palos professional buildings and the hospital where people can park without a permit. Many of the people who park on Paraiso Court do not care about how their parking affects the look, feel, or functioning of our residential neighborhood. The closer they can park to where they work the better, regardless of its impact, even if it is unsightly or dangerous. (E.g., see attached photo taken 3-3-21 at the N/E corner of Paraiso Ct. and Via Paraiso.)

A few years ago, early one foggy morning while backing out of my driveway, I hit the rear end quarter panel of a car parked with its rear end jutting into my driveway. It did not damage my car, but it left a substantial dent in their quarter panel. I left a note and never heard back from them because their fault was apparent. Our street has large beautiful curbside trees. The non-residential parking clogs the street before the street sweeper arrives so that during fall, our street and gutters are always full of leaves unless we do the sweeping on the weekends or after 5:00. Criminal activity has been reported by neighbors who have seen activity consistent with drug dealing from cars parked on our street.

Clearly the parking problem is more significant for the residents on the legs of the court that intersect Via Paraiso, but it affects all who live on the Court. Thank you for your consideration of this important issue.
