**A RESOLUTION OF THE CITY OF SALINAS CITY COUNCIL APPROVING A PROFESSIONAL SERVICE AGREEMENT WITH TINA LA PERLE FOR HOMELESS SERVICES INTERVENTION AND COORDINATION**

**WHEREAS**, since 2019, in order to ensure an effective use of funds and the identification and utilization of “best practices” in regard to the provision of homeless services, the City has utilized the professional services of Tina La Perle; and

**WHEREAS**, Tina La Perle’s services have been instrumental in assisting the City to conduct vital outreach and identify effective, safe practices to house and protect vulnerable, homeless City residents in order to prevent, prepare for, and respond to the COVID-19 pandemic; and

**WHEREAS**, on January 1, 2021, the City and County of Monterey entered into an agreement to provide additional County Whole Person Care (WPC) program funds towards homelessness related activities; and

**WHEREAS**, the City and the California Department of Housing and Community Development (HCD) executed a CARES Act Emergency Solutions Grants (ESG-CV) standard agreement in the amount \$4,072,100 on November 13, 2020; and

**WHEREAS**, per HCD ESG-CV Program guidelines, the City is eligible to utilize up to \$148,800 for administration funds; and

**WHEREAS**, the City was awarded CARES Act Emergency Solutions Grants (ESG-CV) funds from the U.S. Department of Housing and Urban Development (HUD) in the amount \$6,432,171 through a Substantial Amendment to the FY 19-20 Annual Action Plan; and

**WHEREAS**, per HUD ESG-CV Program guidelines, the City is eligible to utilize up to \$597,217 of funds for program administration; and

**WHEREAS**, the City intends to utilize \$50,000 from WPC, \$40,000 from HUD ESG-CV Administration funds, and \$26,112 from HCD ESG-CV administration funds to fund this Professional Service Agreement for the term of July 1, 2021 to June 30, 2022 in an amount not to exceed \$116,112.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Salinas that it hereby authorizes and directs the City Manager or designee, for and on behalf of the City of Salinas, to execute this Professional Service Agreement along with any amendments, contracts or related documents that are deemed necessary to carry out the terms and conditions as set forth in this Professional Service Agreement as presented to the City Council on this date.
