RESOLUTION NO. (N.C.S.)

A RESOLUTION OF THE SALINAS CITY COUNCIL APPROVING TWO (2) PARKING STALLS AND FORTY (40) FEET OF YELLOW LOADING ZONES, 345 FEET OF WEDNESDAY 8:00 A.M. TO 1:00 P.M. PARKING RESTRICTIONS AT THE MONTEREY COUNTY GOVERNMENT CENTER'S CHURCH STREET FRONTAGE, AND 125 FEET OF "NO STOPPING" RED ZONES ALONG MONTEREY COUNTY GOVERNMENT CENTER'S WEST ALISAL STREET FRONTAGE

WHEREAS, at its meeting of March 4, 2008, Resolution No. 19418 was approved allowing a temporary yellow loading zone at the Monterey County Government Center's West Alisal Street frontage and a temporary yellow loading zone at 230 Church Street, west of the Church Street and Gabilan Street intersection during the construction of the Monterey County Government Center; and

WHEREAS, City Staff received a request from Steven Fisher, Facilities and Security Manager for County of Monterey, to install new yellow loading zones along Monterey County Government Center's Church Street frontage and to permanently assign 16 parking stalls along Church Street as "No Parking Wednesdays 8:00 A.M. to 1:00 P.M."; and

WHEREAS, Stopped vehicles along the Monterey County Government Center's West Alisal Street frontage conflicts with the Downtown Complete Streets Project's newly installed bike lanes and staff recommends the installation of 125 feet of "No Stopping" red zones along Monterey County Government Center's West Alisal Street frontage; and

WHEREAS, on September 9, 2021, 2021, the Traffic and Transportation Commission voted unanimously (6-0) to recommend to Council to approve a resolution approving two (2) parking stalls and forty (40) feet of yellow loading zones, 345 feet of Wednesday 8:00 a.m. to 1:00 p.m. parking restrictions at the Monterey County Government Center's Church Street frontage, 125 feet of "No Stopping" red zones along Monterey County Government Center's West Alisal Street frontage, the modification of Church Street into a one-way street with front-in angled parking.

NOW, THEREFORE, BE IT RESOLVED that the Salinas City Council hereby approves the establishment of two (2) parking stalls and forty (40) feet of yellow loading zones

BE IT FURTHER RESOLVED, that the Salinas City Council hereby approves the establishment of 345 feet of Wednesday 8:00 a.m. to 1:00 p.m. parking restrictions at the Monterey County Government Center's Church Street frontage.

BE IT FURTHER RESOLVED, that the Salinas City Council hereby approves the establishment of 125 feet of "No Stopping" red zones along Monterey County Government Center's West Alisal Street frontage.
